SENATE BILL 214

For An Act To Be Entitled

8 "AN ACT TO MAKE AN APPROPRIATION TO THE DEPARTMENT OF
9 FINANCE AND ADMINISTRATION - DISBURSING OFFICER FOR STATE
10 MATCHING FUNDS FOR THE HOT SPRINGS FLOOD CONTROL SURVEY;
11 AND FOR OTHER PURPOSES."

Subtitle

14 "AN ACT FOR THE DEPARTMENT OF FINANCE AND ADMINISTRATION -
15 DISBURSING OFFICER CAPITAL IMPROVEMENT APPROPRIATION."

17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

19 SECTION 1. APPROPRIATIONS. There is hereby appropriated, to the
20 Department of Finance and Administration - Disbursing Officer, to be payable
21 from the General Improvement Fund or its successor fund or fund accounts, the
22 following:

23 (A) For payment of the state matching portion of the Hot Springs Flood
24 Control Project, the sum of \$169,150.

26 SECTION 2. FUNDING TRANSFER. Immediately upon the effective date of
27 this Act, the Chief Fiscal Officer of the State shall transfer on his books
28 and those of the State Treasurer the sum of one hundred sixty nine thousand,
29 one hundred fifty dollars (\$169,150) from the General Revenue Allotment
30 Reserve Fund to the General Improvement Fund or its successor fund or fund
31 accounts to provide funds for the appropriation provided herein.

33 SECTION 3. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
34 authorized by this Act shall be limited to the appropriation for such agency

1 and funds made available by law for the support of such appropriations; and
2 the restrictions of the State Purchasing Law, the General Accounting and
3 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
4 Procedures and Restrictions Act, or their successors, and other fiscal control
5 laws of this State, where applicable, and regulations promulgated by the
6 Department of Finance and Administration, as authorized by law, shall be
7 strictly complied with in disbursement of said funds.

9 SECTION 4. LEGISLATIVE INTENT. It is the intent of the General
10 Assembly that any funds disbursed under the authority of the appropriations
11 contained in this Act shall be in compliance with the stated reasons for which
12 this Act was adopted, as evidenced by the Agency Requests, Executive
13 Recommendations and Legislative Recommendations contained in the budget
14 manuals prepared by the Department of Finance and Administration, letters, or
15 summarized oral testimony in the official minutes of the Arkansas Legislative
16 Council or Joint Budget Committee which relate to its passage and adoption.

18 SECTION 5. CODE. All provisions of this Act of a general and permanent
19 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
20 Code Revision Commission shall incorporate the same in the Code.

21

22 SECTION 6. SEVERABILITY. If any provision of this Act or the
23 application thereof to any person or circumstance is held invalid, such
24 invalidity shall not affect other provisions or applications of the Act which
25 can be given effect without the invalid provision or application, and to this
26 end the provisions of this Act are declared to be severable.

27

28 SECTION 7. GENERAL REPEALER. All laws and parts of laws in conflict
29 with this Act are hereby repealed.

30

31 SECTION 8. EMERGENCY CLAUSE. It is hereby found and determined by the
32 Seventy-Ninth General Assembly meeting in Regular Session, that funds provided
33 by the Seventy-Eighth General Assembly for the operations of the Department of
34 Finance and Administration - Disbursing Officer are, due to unforeseen
35 circumstances, insufficient for the Department of Finance and Administration -

1 Disbursing Officer to continue to provide essential governmental services;
2 that the provisions of this act will provide the necessary monies for the
3 Department of Finance and Administration - Disbursing Officer to continue such
4 services; and that a delay in the effective date of this Act could work
5 irreparable harm upon the proper administration and provision of essential
6 governmental programs. Therefore, an emergency is hereby declared to exist
7 and this Act being necessary for the immediate preservation of the public
8 peace, health and safety shall be in full force and effect from and after the
9 date of its passage and approval.
