# A Bill

**SENATE BILL**

## For An Act To Be Entitled

8 "AN ACT TO AMEND ARKANSAS CODE 16-92-110 TO PROVIDE THAT  
9 THE COURT COSTS LEVIED THEREUNDER SHALL BE REMITTED TO THE  
10 ARKANSAS STATE POLICE RETIREMENT SYSTEM; AND FOR OTHER  
11 PURPOSES."

## Subtitle

14 "AN ACT TO AMEND ARK. CODE 16-92-110 TO PROVIDE THAT THE  
15 COURT COSTS LEVIED THEREUNDER SHALL BE REMITTED TO THE  
16 ARKANSAS STATE POLICE RETIREMENT SYSTEM."

18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20 SECTION 1. Arkansas Code 16-92-110(a)(4) is hereby amended to read as  
21 follows:

22 "(a) (4) (A) All moneys collected under this subsection shall  
23 forthwith be paid over by the collecting officer to the county treasurer, who  
24 shall credit the moneys on his records to a fund to be designated and known as  
25 the State Police Retirement Fund; and on or before the tenth day of the next  
26 succeeding month, the county treasurer shall remit, by check, all those costs  
27 directly to the Arkansas State Police Retirement System.

28 (B) Upon receipt thereof by the Arkansas State Police  
29 Retirement System, the moneys shall then be deposited with the State Treasurer  
30 or with a bank designated by the Board of Trustees of the Arkansas State  
31 Police Retirement System.

32 (C) The moneys collected and remitted to the State  
33 Treasurer and received by the State Treasurer for deposit to the credit of the  
34 State Police Retirement Fund are declared to be trust fund income."

35

1           SECTION 2. All provisions of this act of a general and permanent nature  
2 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code  
3 Revision Commission shall incorporate the same in the Code.

5           SECTION 3. If any provision of this act or the application thereof to  
6 any person or circumstance is held invalid, such invalidity shall not affect  
7 other provisions or applications of the act which can be given effect without  
8 the invalid provision or application, and to this end the provisions of this  
9 act are declared to be severable.

10

11           SECTION 4. All laws and parts of laws in conflict with this act are  
12 hereby repealed.
