SENATE BILL

For An Act To Be Entitled

8 "AN ACT TO PROVIDE THAT THE ARKANSAS GAME AND FISH
9 COMMISSION SHALL NOT BE REQUIRED TO PAY ANY IMPROVEMENT
10 DISTRICT ASSESSMENTS THAT MAY BE ASSESSED AGAINST PROPERTY
11 BELONGING TO THE COMMISSION; AND FOR OTHER PURPOSES."

Subtitle

14 "TO PROVIDE THAT THE GAME AND FISH COMMISSION SHALL NOT BE
15 REQUIRED TO PAY ANY IMPROVEMENT DISTRICT ASSESSMENTS THAT
16 MAY BE ASSESSED AGAINST COMMISSION PROPERTY."

18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20 SECTION 1. Arkansas Code 14-86-605 is amended to read as follows:

21 "14-86-605. (a) Any state agency or commission, owning real property
22 located within a levee, drainage, or any other improvement or district and
23 benefiting from the district shall pay the assessments levied by such
24 districts from the date of implementation."

26 SECTION 2. Arkansas Code 14-86-606 is amended to read as follows:

27 "14-86-606. Sale or transfer of land. The sale or transfer of real
28 property located within a levee, drainage, or other improvement or special
29 assessment district to a state agency or commission, if benefitted by the
30 stated purpose of the improvement district, shall not extinguish any lien for
31 delinquent assessments of such districts or relieve the purchaser or
32 transferee of liability for delinquent assessments in such districts."

34 SECTION 3. Arkansas Code 14-86-607 is amended by inserting an
35 additional subsection at the end thereof to read as follows:

1 "(c) The provisions of Sections 14-86-605 and 606 are not applicable to
2 the Game and Fish Commission and the Game and Fish Commission shall hereafter
3 not be required to pay any improvement district assessments on property owned
4 by the Game and Fish Commission."
5

6 SECTION 4. All provisions of this act of a general and permanent nature
7 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
8 Revision Commission shall incorporate the same in the Code.
9

10 SECTION 5. If any provision of this act or the application thereof to
11 any person or circumstance is held invalid, such invalidity shall not affect
12 other provisions or applications of the act which can be given effect without
13 the invalid provision or application, and to this end the provisions of this
14 act are declared to be severable.
15

16 SECTION 6. All laws and parts of laws in conflict with this act are
17 hereby repealed.
