# A Bill

**SENATE BILL**

## For An Act To Be Entitled

8 "AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES AND  
9 OPERATING EXPENSES FOR THE GATEWAY TECHNICAL COLLEGE WHICH  
10 SHALL BE SUPPLEMENTAL AND IN ADDITION TO THOSE FUNDS  
11 APPROPRIATED BY ACT 931 OF 1991, FOR THE REMAINDER OF THE  
12 BIENNIAL PERIOD ENDING JUNE 30, 1993; AND FOR OTHER  
13 PURPOSES."

## Subtitle

16 "AN ACT FOR THE GATEWAY TECHNICAL COLLEGE SUPPLEMENTAL  
17 APPROPRIATION."

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. APPROPRIATIONS. There is hereby appropriated, to the  
22 Gateway Technical College, to be payable from the Gateway Technical College  
23 Fund, for personal services and operating expenses of the Gateway Technical  
24 College which shall be supplemental and in addition to those funds  
25 appropriated in Section 1 of Act 931 of 1991, for the remainder of the  
26 biennial period ending June 30, 1993, the following:

6 SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of funds

7 authorized by this Act shall be limited to the appropriation for such agency

8 and funds made available by law for the support of such appropriations; and

9 the restrictions of the State Purchasing Law, the General Accounting and

10 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary

11 Procedures and Restrictions Act, the Higher Education Expenditure Restrictions

12 Act, or their successors, and other fiscal control laws of this State, where

13 applicable, and regulations promulgated by the Department of Finance and

14 Administration, as authorized by law, shall be strictly complied with in

15 disbursement of said funds.

17 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General

18 Assembly that any funds disbursed under the authority of the appropriations

19 contained in this Act shall be in compliance with the stated reasons for which

20 this Act was adopted, as evidenced by the Agency Requests, Executive

21 Recommendations and Legislative Recommendations contained in the budget

22 manuals prepared by the Department of Finance and Administration, letters, or

23 summarized oral testimony in the official minutes of the Arkansas Legislative

24 Council or Joint Budget Committee which relate to its passage and adoption.

26 SECTION 4. CODE. All provisions of this Act of a general and permanent

27 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas

28 Code Revision Commission shall incorporate the same in the Code.

29

30 SECTION 5. SEVERABILITY. If any provision of this Act or the

31 application thereof to any person or circumstance is held invalid, such

32 invalidity shall not affect other provisions or applications of the Act which

33 can be given effect without the invalid provision or application, and to this

34 end the provisions of this Act are declared to be severable.

1           SECTION 6. GENERAL REPEALER. All laws and parts of laws in conflict  
2 with this Act are hereby repealed.

4           SECTION 7. EMERGENCY CLAUSE. It is hereby found and determined by the  
5 Seventy-Ninth General Assembly, that funds provided by the Seventy-Eighth  
6 General Assembly for the operations of the Gateway Technical College are, due  
7 to unforeseen circumstances, insufficient for the Gateway Technical College to  
8 continue to provide essential governmental services; that the provisions of  
9 this act will provide the necessary monies for the Gateway Technical College  
10 to continue such services; and that a delay in the effective date of this Act  
11 could work irreparable harm upon the proper administration and provision of  
12 essential governmental programs. Therefore, an emergency is hereby declared  
13 to exist and this Act being necessary for the immediate preservation of the  
14 public peace, health and safety shall be in full force and effect from and  
15 after the date of its passage and approval.
