18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20 SECTION 1. APPROPRIATIONS. There is hereby appropriated, to the Red
21 River Technical College, to be payable from the Red River Technical College
22 Fund, for operating expenses of the Red River Technical College which shall be
23 supplemental and in addition to those funds appropriated in Section 1 of Act
24 935 of 1991, for the remainder of the biennial period ending June 30, 1993,

SECTION 7. EMERGENCY CLAUSE. It is hereby found and determined by the Seventy-Ninth General Assembly, that funds provided by the Seventy-Eighth General Assembly for the operations of the Red River Technical College are, due to unforeseen circumstances, insufficient for the Red River Technical College to continue to provide essential governmental services; that the provisions of this act will provide the necessary monies for the Red River Technical College to continue such services; and that a delay in the effective date of this Act could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after the date of its passage and approval.
