# A Bill

**SENATE BILL 551**

## For An Act To Be Entitled

8 "AN ACT TO PROVIDE FOR A SERVICE CHARGE TO BE LEVIED  
9 AGAINST FUNDS THAT ARE NOT DEPOSITED INTO THE STATE  
10 TREASURY IN THE SAME MANNER AS GENERAL AND SPECIAL  
11 REVENUES ARE CHARGED; AND FOR OTHER PURPOSES."

## Subtitle

14 "AN ACT TO LEVY A SERVICE CHARGE ON CERTAIN CASH FUNDS."

15

16 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

17

18 SECTION 1. For the purpose of this Act, the term "state agency" shall  
19 include all boards, commissions, departments, agencies, institutions, offices  
20 or officers, and any other office or unit of the State of Arkansas created or  
21 established pursuant to law or pursuant to any action of the Governor,  
22 functioning under appropriation of the General Assembly or functioning as a  
23 representative of the State of Arkansas without appropriation of the General  
24 Assembly. "State agency" shall not include the Department of Education and  
25 any of its divisions, community colleges and branches thereof, universities  
26 and branches thereof, technical colleges, technical institutes, postsecondary  
27 vocational technical schools and comprehensive lifelong learning centers.  
28 *"State Agency" shall not include the Office of Commissioner of State Lands, or*  
29 *the Department of Parks and Tourism.*

30 Each state agency, whose annual income or revenue as reflected by the  
31 previous fiscal year's audit exceeds twenty-five thousand dollars (\$25,000),  
32 shall remit by check on the first day of each calendar quarter to the State  
33 Treasurer an amount equal to one and one-half per cent (1½%) of the total  
34 expenditures of the previous calendar quarter from those cash funds as defined  
35 under Arkansas Code §19-4-801, excluding funds received from the federal

1 government or those held in trust by the state agency or *those funds of the*  
2 *various state retirement systems.* The State Treasurer shall deposit each  
3 check as a non-revenue receipt to the credit of the State Central Services  
4 Fund in order to provide financial support for certain required administrative  
5 functions of State Government.

7 SECTION 2. CODE. All provisions of this Act of a general and permanent  
8 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas  
9 Code Revision Commission shall incorporate the same in the Code.

10

11 SECTION 3. GENERAL REPEALER. All laws and parts of laws in conflict  
12 with this Act are hereby repealed.
