26	SECTION 1. $\underline{(a)}$ When a fire department requests the Ar	kansas Local

- 4 (A) The fire department was on the non-certified list
- 5 thereby causing premium tax data to be collected during the year the fire
- 6 department makes an irrevocable decision to join the Arkansas Local Police and
- 7 Fire Retirement System; and
- 8 (B) The fire department makes the irrevocable decision to
- 9 join the Arkansas Local Police and Fire Retirement System no later than
- 10 December 14.
- 11 (2) A fire department that makes an irrevocable decision to join
- 12 the Arkansas Local Police and Fire Retirement System may delay the effective
- 13 date of joining no later than July of the following year and shall still be
- 14 eligible to receive premium taxes distributed to districts in that year.

- 16 SECTION 2. All provisions of this act of a general and permanent nature
- 17 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
- 18 Revision Commission shall incorporate the same in the Code.

- 20 SECTION 3. If any provision of this act or the application thereof to
- 21 any person or circumstance is held invalid, such invalidity shall not affect
- 22 other provisions or applications of the act which can be given effect without
- 23 the invalid provision or application, and to this end the provisions of this
- 24 act are declared to be severable.

- 26 SECTION 4. All laws and parts of laws in conflict with this act are
- 27 hereby repealed.
