20	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21	
22	SECTION 1. The Director of the Department of Finance and Administration
23	shall provide for and issue special Arkansas State Game and Fish Commission
24	motor vehicle license plates in the manner and subject to the conditions
25	prescri bed herein.
26	
27	SECTION 2. The special motor vehicle license plates shall be designed
28	by the Arkansas State Game and Fish Commission, and shall be submitted for
29	design approval by the Director of the Department of Finance and
30	Administration. The Arkansas Game and Fish Commission may periodically submit
31	newly designed license plates for approval and issue by the Director of the
32	Department of Finance and Administration, but not more than one (1) license
33	plate shall be issued per calendar year. Upon approval of the design by the
34	Director, the Arkansas Game and Fish Foundation shall remit to the Department
35	of Finance and Administration a fee in the amount of six thousand dollars
36	(\$6,000) to cover the cost of the initial order of each newly designed license

1 plate. Such fee shall be deposited to the State Central Services Fund for the 2 benefit of the Revenue Division and shall be credited as supplemental and in 3 addition to all other funds as may be deposited for the benefit of the Revenue 4 Division. Such fee shall not be considered or credited as to the Revenue 5 Division as "direct revenues". 6 7 SECTION 3. Upon payment of the fee required by law for the registration 8 of the vehicle, payment of twenty-five dollars (\$25.00) to cover the design 9 use contribution, and payment of an additional ten dollar (\$10.00) handling 10 and administrative fee for the issuance of the special Arkansas State Game and Fish Commission plate, the <u>Department of Finance and Administration shall</u> 11 12 issue to the vehicle owner an Arkansas State Game and Fish Commission license 13 plate which shall bear the approved design. The handling and administrative 14 fee of ten dollars (\$10.00) shall be deposited to the State Central Services 15 Fund for the benefit of the Revenue Division and shall be credited to the Revenue Division as supplemental and in addition to all other funds as may be 16 17 deposited for the benefit of the Revenue Division. The handling and <u>administrative fee shall not be considered or cre</u>dited to the Revenue Division 18 as 'direct revenues'. The design use contribution of twenty-five dollars 19 (\$25.00) shall be deposited to the Game Protection Fund to be used by the 20 Arkansas State Game and Fish Commission for the purpose of sponsoring college 21 22 scholarships related to the field of conservation, funding land purchases for 23 the benefit of the public, and for conservation education programs. 24 25 SECTION 4. Special Arkansas State Game and Fish Commission license 26 plates issued under this act may be renewed annually in accordance with the 27 procedures set out in Section 3 either in person or by mail, or by facsimile pursuant to Arkansas Code § 27-14-1012 and § 27-14-1013. Registration may 28 29 continue from year to year as long as it is renewed each year within the time 30 and manner required by law. A motor vehicle owner who was previously issued a plate with the Arkansas State Game and Fish Commission design authorized by 31 32 this act and who does not pay a design use contribution of twenty-five dollars 33 (\$25.00) at the subsequent time of registration, shall be issued a new plate 34 which does not bear the Arkansas Game and Fish Commission design. Upon 35 expiration, or if a special Arkansas Game and Fish Commission license plate is lost, it may be replaced with a regular license plate at the fee specified in 36

1	§ 27-14-602 (b) (6). If the special Arkansas Game and Fish Commission license
2	plate is replaced with a new Arkansas Game and Fish Commission license plate,
3	the owner shall be required to pay the additional administrative cost of
4	issuance as set forth in Section 3 of this act.
5	
6	SECTION 5. Special Arkansas Game and Fish Commission license plates
7	issued under this act may be transferred from one vehicle to another pursuant
8	to Arkansas Code § 27-14-914.
9	
10	SECTION 6. The special Arkansas State Game and Fish Commission license
11	plates shall comply with all other state motor vehicle laws relating to
12	registration and licensing of motor vehicles except as herein specifically
13	provi ded.
14	
15	SECTION 7. The Director of the Department of Finance and Administration
16	shall promulgate such reasonable rules and regulations and prescribe such
17	forms as he determines to be necessary for effectively and efficiently
18	carrying out the intent and purposes of this act.
19	
20	SECTION 8. All provisions of this Act of a general and permanent nature
21	are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
22	Revision Commission shall incorporate the same in the Code.
23	
24	SECTION 9. If any provision of this Act or the application thereof to
25	any person or circumstance is held invalid, such invalidity shall not affect
26	other provisions or applications of the Act which can be given effect without
27	the invalid provision or application, and to this end the provisions of this
28	Act are declared to be severable.
29	
30	SECTION 10. All laws and parts of laws in conflict with this Act are
31	hereby repeal ed.
