27	SECTION 1. (a) The Un	niversity of Arkansas for Medical Se	ciences shall
28	conduct a study, through th	ne Area Health Education Centers (A	HECS), to
29	determine on a county by county basis the primary health needs of the State.		
30	(b) The AHECS shall, based upon the findings and results of the study required		
31	in subsection (a) of this S	Section, review and propose modifica	ations in their
32	mission statements to more clearly reflect the current conditions of the		
33	primary health needs of the State. The proposed modifications to the AHECS'		
34	mission statements shall be submitted for review and consideration by the		
35	Governor and the appropriate legislative committee, as determined by the		
36	Legislative Council, before	e October 1, 2000.	



1 2 SECTION 2. (a) Immediately upon the effective date of this Act, or as 3 soon as funds are available in the Tobacco Settlement Cash Holding Fund, the 4 State Board of Finance shall transfer three hundred thousand dollars (\$300,000) from the Tobacco Settlement Cash Holding Fund to the cash funds of 5 6 the Area Health Education Centers of the University of Arkansas for Medical 7 Sciences in order to provide funding for the study required in subsection (a) 8 of Section 1 of this Act. 9 (b) The State Board of Finance shall transfer one million dollars (\$1,000,000) on January 1, 2001 and two million dollars (\$2,000,000) on April 15, 2002 and 10 11 on April 15 of each year thereafter from the Tobacco Settlement Cash Holding Fund to the cash funds of the Area Health Education Centers of the University 12 13 of Arkansas for Medical Sciences in order to provide funding to expand health care services in each county as a result of the findings of the study in 14 15 subsection (a) of Section 1 and the change in the mission statement in 16 subsection (b) of Section 1 of this Act. 17 18 SECTION 3. EMERGENCY CLAUSE. It is hereby found and determined by the 19 Eighty-second General Assembly that a study of the primary health needs in the 20 State and the implementation of the study results by the Area Health Education 21 Centers of the University of Arkansas for Medical Sciences is vitally 22 necessary to improve the health of Arkansas citizens and that funds necessary 23 to implement the health services needed are provided by this Act. Therefore, 24 an emergency is declared to exist and this act being immediately necessary for 25 the preservation of the public peace, health and safety shall become effective 26 on the date of its approval by the Governor. If the bill is neither approved nor vetoed by the Governor, it shall become effective on the expiration of the 27 28 period of time during which the Governor may veto the bill. If the bill is 29 vetoed by the Governor and the veto is overridden, it shall become effective 30 on the date the last house overrides the veto. 31 32 33 34 35
