13	"TO AMEND SENATE RULE 10.03 AND SENATE
14	RULE 10.04 CONCERNING VOTING."

17	WHEREAS, the General Assembly of the State of Arkansas is a part-time
18	legislative body; and
19	WHEREAS, the members of the Arkansas Senate are also engaged in various
20	private professions, vocations, occupations, and employment that is necessary
21	to sustain their livelihood; and
22	WHEREAS, the Governor of the State of Arkansas is empowered to call
23	Extraordinary Sessions of the General Assembly at any time between the regular
24	biennial sessions of the General Assembly; and
25	WHEREAS, a member's attendance at such Extraordinary Session may pose an
26	unavoidable conflict with prior commitments made by the Senator relative to
27	his/her private business matters;
28	
29	NOW THEREFORE,
30	BE IT RESOLVED BY THE SENATE OF THE EIGHTY-SECOND GENERAL ASSEMBLY OF THE
31	STATE OF ARKANSAS:
32	
33	That Rule 10.03 of the Parliamentary Manual of the Senate is hereby
34	amended to read as follows:
35	"10.03 Upon the call for the yeas and nays on any question, each member
36	shall answer from his seat. Provided, any member shall have the right to

1	explain his vote in writing. <u>In the event an Extraordinary Session is called</u>
2	by the Governor and a Senator will be unavoidably absent, the absent Senator
3	shall be permitted to cast a vote on any question by participating in a
4	conference telephone call which shall take place in the Senate chamber. Upon
5	the calling of the roll, the names of the members shall be called
6	alphabetically by surname and the absent Senator shall vote when his name is
7	called."
8	And
9	That Rule 10.04(b) of the Parliamentary Manual of the Senate is hereby
10	amended to read as follows:
11	"10.04(b) Pairs are counted when signed by both Senators and with one
12	(1) of the members present. During an Extraordinary Session of the General
13	Assembly, the absent Senator may present to the Secretary of the Senate his or
14	her signature and pair by facsimile or similar electronic transmission upon a
15	form approved by the Secretary of the Senate."
