9 AN ACT TO AMEND ARKANSAS CODE § 7-6-102, TO  
10 CLARIFY THE FILING REQUIREMENTS AND DEADLINES FOR

12 OFFICE; AND FOR OTHER PURPOSES.

## Subtitle

15 AN ACT TO AMEND ARKANSAS CODE § 7-6-102, TO  
16 CLARIFY THE FILING REQUIREMENTS AND  
17 DEADLINES FOR THOSE INDIVIDUALS WISHING TO  
18 FILE FOR PUBLIC OFFICE.

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
21

22 SECTION 1. Arkansas Code § 7-6-102(e), regarding political practices  
23 pledge and filing requirements for individuals running for public office, is  
24 amended to read as follows:

25 ~~(e) [As amended by Acts 1989, No. 755, § 1.] The Secretary of State or~~  
26 ~~the county clerks of each county, depending on the office, shall notify~~  
27 ~~candidates who have failed to file timely political practices pledges. Only~~  
28 ~~candidates who refuse to file signed pledges within five (5) days of~~  
29 ~~notification of failure to file may be kept off the ballot or made ineligible~~  
30 ~~to be write-in candidates.~~

31 (e) ~~[As amended by Acts 1989, No. 912, § 3.]~~ (1) The failure of any  
32 candidate to ~~sign and file the pledge shall be justifiable grounds to keep~~  
33 prevent the candidate's name from appearing on the ballot.

34 ~~(2)(A) However, within five (5) days following the first Tuesday~~  
35 ~~in April before the preferential primary election or within five (5) days~~  
36 ~~from which the pledge is required to be filed, the Secretary of State or the~~

1 ~~county clerk shall notify, by certified mail which requires a return receipt~~  
2 ~~signed by the candidate, those candidates who have failed to file a signed~~  
3 ~~political practice pledge. Such notice shall include a copy of the written~~  
4 ~~pledge required by this section.~~

5 ~~(B) Failure of the state or district candidate to file~~  
6 ~~with the Secretary of State or of the county, municipal, or township~~  
7 ~~candidate to file with the county clerk within twenty (20) days of receipt or~~  
8 ~~refusal of this notice shall prevent the candidate's name from appearing on~~  
9 ~~the ballot.~~
