12 AND PAPERWORK; AND FOR OTHER PURPOSES.

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
23

24 SECTION 1. Arkansas Code § 6-11-105 is amended to read as follows:
25 6-11-105. Powers and duties.

26 (a) The State Board of Education shall:

- 27 (1) Have general supervision of the public schools of the state;
28 (2) Prepare and distribute plans and specifications for the
29 construction and equipment of school buildings and approve plans and
30 expenditures of public school funds for all new school buildings;
31 (3) Recommend courses of study for the public schools and
32 teacher training institutions;
33 (4) Prescribe rules and regulations for the sanitary inspection
34 of all buildings and for the examination of pupils to detect contagious and
35 infectious diseases and physical defects;
36 (5) Issue certificates based upon credentials presented by

1 applicants for certificates to teach in the public schools of the state;

2 (6) Qualify and standardize public schools and prescribe
3 requirements for accrediting and grading public schools;

4 (7) Supervise the operation of school district budgets;

5 (8) Supervise the purchase and distribution of textbooks;

6 (9) Take such other action as it may deem necessary to promote
7 the physical welfare of school children and promote the organization and
8 increase the efficiency of the public schools of the state; ~~and~~

9 (10) Perform all other functions which may now or hereafter be
10 delegated to the board by law. However, nothing in this act shall prohibit
11 the board and the Department of Education from issuing teachers' certificates
12 upon the results of teachers' examinations as now provided by law; and

13 (11)(A) Eliminate unnecessary reports and paperwork by yearly
14 identifying and compiling a list of all reports that are required from local
15 school districts by the Department of Education or the State Board of
16 Education for the school year; and

17 (B) Adopting policies to ensure, except as allowed under
18 subdivision (b), that local school districts are not required by the State
19 Board of Education or the Department of Education to:

20 (i) Provide information that is already available on
21 a Department of Education student information management system or housed
22 within the Department of Education;

23 (ii) Provide the same written information more than
24 once during a school year unless the information has changed during the
25 school year; or

26 (iii) Complete forms, for children with
27 disabilities, that are not necessary to ensure compliance with the federal
28 Individuals with Disabilities Education Act.

29 (b) The State Board of Education may require information available on
30 a Department of Education student information management system or require
31 the same information twice if the State Board can demonstrate a compelling
32 need and can demonstrate there is not a more expeditious manner of getting
33 the information.

34 ~~(b)(c)~~ The board may organize and, from time to time, change and alter
35 the department into branches or sections as may be found necessary and
36 desirable by the Director of the Department of Education to perform all

1 proper functions and to render maximum service relating to the operation and
2 improvement of the general education programs of the state.

3 ~~(e)~~(d) The board shall adopt rules and regulations for its meetings
4 and proceedings as it deems advisable.
