13	SECTION 2. Arkansas Code § 24-7-601(c), concerning the limitation on		
14	granting credited service for unused sick leave under the Arkansas Teacher		
15	Retirement System, is amended to read as follows:		
16	(c) (l) Days of absence from service because of sickness shall be		
17	considered as service if the days are paid sick leave.		
18	(2) Days of paid sick leave shall not be considered service if		
19	the payment is for unused sick leave.
