Arkansas Code § 7-5-409 (f)-(h), concerning materials 6 furnished to qualified voters, is amended to read as follows: 7 (f) The county clerk shall not provide more than five (5) absentee 8 ballots two (2) absentee ballots per election to any designated bearer, nor 9 shall the county clerk accept delivery of more than five (5) absentee ballots two (2) absentee ballots per election from any designated bearer. 10 11 The county clerk shall not deliver in person or by any other means 12 of transmittal more than five (5) absentee ballots two (2) absentee ballots per election to the individual authorized to receive the absentee ballots 13 14 unless: 15 (1) There there are more than five (5) persons lawfully 16 registered at the same address as the individual obtaining the absentee 17 ballots, in which case the individual may only receive the same number of absentee ballots as persons lawfully registered at the same address; or. 18 19 (2) There are more than five (5) persons lawfully registered at 20 the address for which the designated bearer or authorized agent is obtaining 21 the absentee ballots, in which case the designated bearer may only receive 22 the same number of absentee ballots as persons lawfully registered at the 23 same address. 24 (h) A designated bearer shall only be allowed to pick up five (5) two 25 (2) absentee ballots from the county clerk per election and shall only be 26 allowed to do so during the fifteen (15) days prior to a preferential or 27 general election and seven (7) days prior to a general primary election. 28 29 SECTION 3. Arkansas Code § 7-5-411(a)(2), concerning methods of voting 30 absentee, is amended to read as follows: 31 (2)(A) By delivery of the ballot to the county clerk of the 32 county of residence of the voter not later than 7:30 p.m. on election day by 33 a relative of the voter, the designated bearer, or the authorized agent of 34 the absentee voter who is medically unable to vote at the regular polling 35 site upon proper verification of the signature of the voter by the county

clerk and validation of the identity of the authorized agent.
