## For An Act To Be Entitled

9 AN ACT TO RENAME THE ARKANSAS STATE BUILDING  
10 SERVICES, THE STATE BUILDING SERVICES COUNCIL,  
11 AND THE STATE BUILDING SERVICES FUNDS; AND FOR  
12 OTHER PURPOSES.

## Subtitle

14 AN ACT TO RENAME THE ARKANSAS STATE  
15 BUILDING SERVICES, THE STATE BUILDING  
16 SERVICES COUNCIL, AND STATE BUILDING  
17 SERVICES FUNDS.

21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
22

23 SECTION 1. Legislative intent and purpose.

24 (a) The General Assembly recognizes that confusion exists in the  
25 public's perception regarding the purpose of the Arkansas State Building  
26 Services due to the inconsistency between the name of the agency and its  
27 established purposes.

28 (b) The purpose of this act is to:

29 (1) Provide the agency with a name that more accurately  
30 describes its role as an agency, that is intended to fulfill the  
31 legislatively established purposes of leasing, property management, design  
32 review, and contract oversight of capital improvements; and

33 (2) Provide its supervisory board with a name consistent with  
34 the agency's name change.

36 SECTION 2. The Arkansas State Building Services, as established in



1 Arkansas Code § 22-2-101, shall be known as the Arkansas Building Authority.

2  
3 SECTION 3. The State Building Services Council, as established in  
4 Arkansas Code § 22-2-106, shall be known as the Arkansas Building Authority  
5 Council.

6  
7 SECTION 4. The Arkansas State Building Services Maintenance Fund, as  
8 established in Arkansas Code § 19-5-1406, shall be known as the Arkansas  
9 Building Authority Maintenance Fund.

10  
11 SECTION 5. The State Building Services Fund, as established in  
12 Arkansas Code § 22-2-119, shall be known as the Arkansas Building Authority  
13 Fund.

14  
15 SECTION 6. The State Building Services Account of the General  
16 Improvement Fund Account, as established in Arkansas Code § 19-5-308, shall  
17 be known as the Arkansas Building Authority Account of the General  
18 Improvement Fund Account.

19  
20 SECTION 7. The State Building Services Real Estate Fund, as  
21 established in Arkansas Code § 19-5-1206, shall be known as the Arkansas  
22 Building Authority Real Estate Fund.

23  
24 SECTION 8. The Arkansas Code Revision Commission shall make all  
25 appropriate name changes in the Arkansas Code to implement this act.
