11 AN ACT TO MAKE AN APPROPRIATION FOR PROVIDING
12 ADDITIONAL SUPPORT FOR THE SCHOOL OF AGRICULTURE,
13 AQUACULTURE/FISHERIES, HUMAN SCIENCES RESEARCH
14 AND EXTENSION PROGRAMS IN ORDER TO MATCH FEDERAL
15 FUNDS FOR THE UNIVERSITY OF ARKANSAS AT PINE
16 BLUFF WHICH SHALL BE SUPPLEMENTAL AND IN ADDITION
17 TO THOSE FUNDS APPROPRIATED BY ACT 227 OF 2001;
18 AND FOR OTHER PURPOSES.

29 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
30

31 SECTION 1. APPROPRIATION - AGRICULTURE, AQUACULTURE/FISHERIES, HUMAN
32 SCIENCES RESEARCH AND EXTENSION PROGRAMS. There is hereby appropriated, to
33 the University of Arkansas at Pine Bluff, to be payable from the University
34 of Arkansas at Pine Bluff Fund, for providing additional support for the
35 Agriculture, Aquaculture/Fisheries, Human Sciences Research and Extension
36 Programs of the University of Arkansas at Pine Bluff which shall be

1 supplemental and in addition to those funds appropriated in Section 3 of Act
2 227 of 2001, the following:

11 SECTION 2. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 12 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUNDING
 13 TRANSFER. Immediately upon the effective date of this act, the Chief Fiscal
 14 Officer of the State shall transfer on his books and those of the State
 15 Treasurer the sum of one million seventy three thousand dollars (\$1,073,000)
 16 from the General Improvement Fund or its successor fund or fund accounts to
 17 the University of Arkansas at Pine Bluff Fund to provide funds for the
 18 appropriation provided herein.

20 SECTION 3. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized
 21 by this act shall be limited to the appropriation for such agency and funds
 22 made available by law for the support of such appropriations; and the
 23 restrictions of the State Purchasing Law, the General Accounting and
 24 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
 25 Procedures and Restrictions Act, the Higher Education Expenditures
 26 Restrictions Act, or their successors, and other fiscal control laws of this
 27 State, where applicable, and regulations promulgated by the Department of
 28 Finance and Administration, as authorized by law, shall be strictly complied
 29 with in disbursement of said funds.

30

31 SECTION 4. LEGISLATIVE INTENT. It is the intent of the General Assembly
 32 that any funds disbursed under the authority of the appropriations contained
 33 in this act shall be in compliance with the stated reasons for which this act
 34 was adopted, as evidenced by the Agency Requests, Executive Recommendations
 35 and Legislative Recommendations contained in the budget manuals prepared by
 36 the Department of Finance and Administration, letters, or summarized oral

1 testimony in the official minutes of the Arkansas Legislative Council or
2 Joint Budget Committee which relate to its passage and adoption.

3
4 SECTION 5. EMERGENCY CLAUSE. It is found and determined by the General
5 Assembly, that funds provided by the General Assembly for the operations of
6 the University of Arkansas at Pine Bluff are, due to unforeseen
7 circumstances, insufficient for the University of Arkansas at Pine Bluff to
8 continue to provide essential governmental services; that the provisions of
9 this act will provide the necessary monies for the University of Arkansas at
10 Pine Bluff to continue such services; and that a delay in the effective date
11 of this Act could work irreparable harm upon the proper administration and
12 provision of essential governmental programs. Therefore, an emergency is
13 hereby declared to exist and this Act being necessary for the immediate
14 preservation of the public peace, health and safety shall be in full force
15 and effect from and after the date of its passage and approval.

16 If the bill is neither approved nor vetoed by the Governor, it shall become
17 effective on the expiration of the period of time during which the Governor
18 may veto the bill. If the bill is vetoed by the Governor and the veto is
19 overridden, it shall become effective on the date the last house overrides
20 the veto.
