2	SECTION 2. Arkansas Code Title 6, Chapter 15, is amended to add an
3	additional subchapter to read as follows:
4	
5	6-15-1601. Purpose and Intent.
6	The 84th General Assembly recognizes the mandate of the Arkansas
7	Supreme Court to provide an equal opportunity for children in the state to
8	obtain an adequate education. By passing House Bill 1115 to create a joint
9	committee to determine what is necessary to provide an adequate education,
10	the General Assembly has set a course to develop a deliberate and organized
11	method of improving the system of education in the state. In his 2001
12	opinion in Lake View, Chancellor Collins Kilgore noted that there are three
13	(3) elements for an adequate education system; one element being the state
14	must clearly specify its expectations of student achievement. In his final
15	order, Chancellor Kilgore acknowledged that Arkansas currently has that
16	element in place. With that favorable ruling, the General Assembly finds
17	that piece meal attempts to change standards of accreditation would be
18	counterproductive to the deliberate and organized course set by the General
19	Assembly; and therefore, codification of the State Board of Education's
20	existing Standards of Accreditation of Arkansas public schools will ensure
21	that our schools stay on course until necessary changes can be undertaken in
22	a deliberate, organized, and efficient manner. The key to a standards-based
23	system of education is longitudinal consistency. Dramatically changing the
24	required curriculum would unnecessarily upset that consistency.
25	
26	6-15-1602. Standards for accreditation of Arkansas public schools.
27	(a) The provisions as set forth under this subchapter shall be the
28	standards for accreditation of Arkansas public schools and shall repeal the
29	standards for accreditation of Arkansas public schools adopted by the State
30	Board of Education.
31	(b) This subchapter may be cited as the "Standards For Accreditation
32	<u>Of Arkansas Public Schools".</u>
33	
34	6-15-1603. Equal educational opportunities.
35	All school districts' policies and actions shall be nondiscriminatory
36	and shall be in compliance with state and federal laws.

2	6-15-1604. Goals and administration of Arkansas schools - State and
3	national goals.
4	(a) It is well established by history and law that education is a
5	state responsibility.
6	(b) As a framework for school district planning, a set of statewide
7	and national goals for education and a long-term plan to meet these goals
8	have been developed.
9	
10	6-15-1605. Goals and administration of Arkansas schools - School
11	district goals.
12	(a)(1) Each school district in Arkansas shall be required to develop,
13	with appropriate staff and community participation, a five-year educational
14	plan. School district goals shall be compatible with state and national
15	educational goals and shall address local needs.
16	(2) The plan shall be filed with and reviewed by the Department
17	of Education annually.
18	(b) Each school district shall provide and publish, in a newspaper
19	with general circulation in the district before November 15 of each school
20	year, a report to the public detailing progress toward accomplishing program
21	goals, accreditation standards, and proposals to correct deficiencies.
22	(c) Each school shall systematically, and at least annually, explain
23	its policies, programs, and goals to the community in a public meeting that
24	provides opportunities for parents and other members of the community to ask
25	questions and make suggestions concerning the school program.

27	6-15-1606. School district administration - Operating policies and
28	procedures.
29	Each school board shall adopt written policies for the operation of the
30	school district in accordance with guidelines established by the Department
31	of Education.

33	6-15-1607. School district administration - Records and reports.
34	(a) Each school shall maintain all reports and records necessary for
35	effective planning, operation, and education.
36	(b)(1) Each school district shall annually submit a report to the

1	Department of Education appraising its students' performance.
2	(2) The report shall be prepared in accordance with guidelines
3	developed by the Department of Education.
4	
5	6-15-1608. School district administration - School boards.
6	(a) Each school board, prior to November 15 of each year, shall hold a
7	public meeting, at a time and place convenient for a majority of the school
8	patrons and employees, to review and discuss its annual report detailing
9	progress toward accomplishing its district's program objectives,
10	accreditation standards, and proposals to correct deficiencies.
11	(b) All accreditation and evaluation studies and reports shall be
12	reported and discussed in a public meeting at a time and place convenient for
13	a majority of the school patrons and employees.

15	6-15-1609. School district administration - School goals.
16	(a)(1) The administrators, teachers, other school staff, and parents
17	of each school shall develop an annual school improvement plan to monitor
18	that school's progress and to project its continuing needs.
19	(2) The annual school improvement plan shall be filed with and
20	reviewed by the Department of Education.
21	(b) Each school shall review in-depth each curriculum area at least
22	every five (5) years.

24	6-15-1610. Active community involvement.
25	(a) Each school district shall form a coalition of parents,
26	representatives of agencies and institutions, and of business and industry to
27	develop and implement a plan for effective and efficient community
28	involvement in the delivery of comprehensive youth services and support.
29	(b) Each individual school shall investigate and, where feasible,
30	utilize community resources in the instructional program of the school.
31	
32	6-15-1611. Curriculum - Course content frameworks.
33	(a)(1) The Department of Education shall appoint committees to write
34	curriculum frameworks based on the adopted Arkansas Student Learning
35	Expectations.
36	(2) Each committee shall consist of teachers and instructional

1	supervisory personnel from public schools assisted by teachers from
2	institutions of higher education.
3	(3) Committees will meet periodically to review, revise, and
4	update the curriculum frameworks.
5	(b) Each accredited school shall use these curriculum frameworks to
6	plan instruction leading to student demonstration of the Arkansas content
7	standards.
8	(c)(l) The Department of Education, with advice from public schools
9	and institutions of higher education, shall devise an assessment system that
10	will measure progress toward meeting the content standards expressed in the
11	Arkansas Curriculum Frameworks.
12	(2) These evaluations shall serve as a major factor in
13	determining the accreditation status of public schools.
14	
15	6-15-1612. Curriculum - Early childhood education curriculum.
16	The early childhood education curriculum shall be developmentally
17	appropriate for the age span of the children within the groups and
18	implemented with attention to the different needs, interests, and
19	developmental levels of those individual children.
20	
21	6-15-1613. Curriculum - Core curriculum.
22	(a)(1) The core curriculum for grades kindergarten through eight (K-8)
23	shall encompass all types of developmentally appropriate learning experiences
24	and provide for differences in rates of learning among children.
25	(2) It shall emphasize reasoning and problem solving,
26	communicating, connecting such as linking knowledge, skills, and other

35	frameworks and that fit the achievement levels of the students assigned to
36	each teacher.

1	(b) Each school may utilize purchasing agreements arranged by the
2	Department of Education to achieve the greatest economy in spending state
3	<u>funds.</u>
4	
5	6-15-1617. Instruction - Discipline.
6	(a) Guidelines for the development of student discipline policies
7	shall be established by the Department of Education. Each school district
8	shall adopt written discipline policies consistent with those guidelines that
9	include a code of student behavior.
10	(b) Each district's written policies shall be filed with the
11	Department of Education.
12	(c) Local districts and individual schools shall involve parents,
13	staff, and students in the formulation and review of their student discipline
14	policies, rules, and procedures.
15	(d) Schools shall inform students and parents of the rules and
16	procedures by which the school is governed. Schools shall make the students
17	aware of the behavior that will call for disciplinary action, as well as the
18	types of corrective actions that may be imposed.
19	(e) Students and parents shall acknowledge that they have received and
20	understand the school's discipline policies by a signed statement. The
21	school shall document procedures and methods used to inform parents and
22	students of the policy.
23	(f) Teachers and administrators, classified school employees, and
24	volunteers shall be provided with appropriate student discipline training
25	under § 6-18-501, § 6-18-502, and § 6-18-506.
26	
27	6-15-1618. Instruction - Extracurricular activities.
28	(a) Each school district shall adopt a written policy on
29	extracurricular and non-instructional activities and their appropriate place
30	in the school program.
31	(b) The policy shall limit and control interruptions of instructional
32	time in the classroom and the number of absences for such activities.
33	
34	6-15-1619. Instruction - Requirements for participation in
35	extracurricular activities.
36	Each school district shall adopt a written policy consistent with

1	applicable State Board of Education rules and regulations, specifying the
2	requirements students must meet to be eligible to participate in
3	extracurricular activities.
4	
5	6-15-1620. Instruction - Homework and independent study skills.
6	Each school district shall adopt a written policy for appropriate and
7	meaningful homework. The policy shall promote the development of students'
8	independent study skills and work to be done outside the classroom which will
9	reinforce and strengthen academic skills, broaden the educational experiences
10	of students, and relate those experiences to the real life of the community.
11	Parents shall be notified of the policy at the beginning of each school year.
12	
13	6-15-1621. Attendance and enrollment - Mandatory attendance.
14	All children who are ages five (5) through seventeen (17) on or by
15	September 15 are required to be in school that school year with the exception
16	of:
17	(1) Five-year-old children for whom kindergarten has been waived by
18	the parent, guardian, or person having custody or charge;
19	(2) Students who have received a high school diploma or its
20	equivalent; or
21	(3) Students who are enrolled in a postsecondary vocational-technical
