1 (B) Funds collected under the provisions of § 8-6-607 and 2 deposited in the State Treasury to the credit of the Solid Waste Management 3 and Recycling Fund, less up to twenty-five percent (25%) for administrative 4 support for the department, shall be annually allocated to each of the 5 approved regional solid waste management districts for costs eligible for 6 grant assistance utilizing a combination of two (2) methods, hereafter 7 referred to as "method A" and "method B".

8 (C) Fifty percent (50%) of set-aside funds will be 9 determined using method A, and fifty percent (50%) will be determined using 10 method B.

(D) The total figures obtained from each method will be combined to arrive at each regional solid waste management district's fund distribution.

(2)(A) Method A:

(i) The department shall determine the amount of funds within each planning and development district organized under § 14-166-201 et seq. through § 14-166-205, and recognized by the Governor, based upon the same distribution as general revenue support is distributed to the planning and development districts in the current fiscal year.

20 (ii) The department shall adjust the distribution 21 within the planning and development districts to coincide with the boundaries 22 of the regional solid waste management districts by determining each county's 23 share of the funds available within each planning and development district. 24 Each county's share shall be based upon the proportion that each county's 25 population bears to the total population in the planning and development 26 district to which the county is assigned, multiplied by the amount of funds 27 determined to be available within the planning and development district. The 28 county's proportional share, as determined, shall be added to all other 29 counties' shares within the same regional solid waste management district. 30 (B) Formula for method A: 31 (i) Begin with fifty percent (50%) of the total 32 remaining grant funds; 33 (ii) Divide equally by the eight (8) regional

This 3 determines the portion per county. 4 (v) Individual county portions are grouped and 5 totaled by each new regional solid waste management district to give each 6 regional solid waste management district's allocation. 7 (3)(A) Method B: The remaining fifty percent (50%) of set-aside 8 funds in a grant round shall be based upon the ratio of the district's 1990 9 or current decennial census population divided by the 1990 or current most 10 recent federal decennial census state population. 11 (B) Formula for method B: 12 (i) Begin with each solid waste management district's total population; 13 14 (ii) Divide by the state's 1990 or current most 15 recent federal decennial census population to get the ratio; and 16 (iii) Multiply by the total remaining grant funds. 17 This equals each regional solid waste (iv) management district's allocation. 18 19 (4) Funds set aside for each district in a grant round that are 20 not awarded to the district will be rolled over to the next grant round. 21 (5) Funds set aside to two (2) or more districts in a grant 22 round may be combined to fund a joint application, provided the joint 23 application has been signed by the regional solid waste management board 24 chairman for each district. 25 (c)(1) Costs eligible for grant assistance include, but are not 26 limited to, costs for solid waste management planning that integrates 27 recycling, costs for public information and education programs that encourage 28 waste reduction and stimulate demand for products produced from recycled 29 materials, costs of waste transfer facilities that integrate recycling in 30 their operations, costs of recycling equipment, and recycling program and 31 market development costs. 32 (2) Grant assistance shall not be provided for the purpose of 33 purchasing mechanical processing equipment or facilities if existing 34 mechanical processing equipment or facilities adequately serve the relevant 35 area, unless the department determines that the equipment or facility is an 36 indispensable component of an otherwise eligible grant project and would more
