19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. Arkansas Code § 21-15-103(g), concerning background checks
22 on certain state employees in designated positions, is amended to read as
23 follows:

24 (g) A state agency shall discharge from employment in a designated
25 position any person who has pleaded guilty or nolo contendere to or been
26 found guilty of any of the following offenses by any court in the State of
27 Arkansas or of any similar offense by a federal court in another state or of
28 any similar offense by a federal court, but only after an opportunity for a
29 hearing conducted in accordance with the Arkansas Administrative Procedure
30 Act, § 25-15-201 et seq.:
