18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20 SECTION 1. Arkansas Code § 2-16-203(b)(1) is amended to read as
21 follows to remove from the section ambiguous language that will be placed in
22 a note to the section:

23 (b)(1)(A) In a lawful proceeding respecting licensing, as defined in
24 the Arkansas Administrative Procedure Act, § 25-15-201 et seq., in addition
25 to or in lieu of any other lawful disciplinary action, the State Plant Board
26 may assess a civil penalty of not more than one thousand dollars (\$1,000) for
27 each violation of any statute, rule, or order enforceable by the board.

28 (B) In no case shall a single application or drift
29 incident by a pesticide applicator be considered multiple violations based on
30 the number of complaints.

31 (C) In no case shall the failure to meet minimum treating
32 standards (~~§ 17-37-101 et seq., Sections III A, III B, III C, and III D~~),
33 except those which require a termiticide application, be considered a
34 violation and subject to a civil penalty.

21 (f) "Mobile home" means every house trailer or other vehicle, with or
22 without wheels, designed for use as living quarters, either permanent or
23 temporary, and, at the time of manufacture, capable of being towed or
24 otherwise transported or drawn upon a highway.

25 (g) "Motor home" means a motor vehicle designed to provide temporary
26 living quarters, built onto an integral part of, or permanently attached to,
27 a self-propelled motor vehicle chassis. The vehicle must contain permanently
28 installed independent life-support systems.

 11 purchase.

3 and safety shall become effective on July 1, 2003.
