18	BE IT ENACTED BY THE GENERAL ASSEMB	LY OF THE STATE OF	ARKANSAS:

20	SECTION 1. Arkansas Code § 5-27-227(a), regarding providing minors			
21	with tobacco products and cigarette papers, is amended to read as follows:			
22	(a) It shall be unlawful for	any person to give	e, barter, <del>or</del> sell <u>, or</u>	
23	<u>deliver</u> to a minor under eighteen (	18) years of age:		
24	(1) Tobacco in any for	m; or		
25	(2) Cigarette papers.

27	SECTION 2. Arkansas Code § 5	-27-227(b), concer	ning providing minors	
28	with tobacco products and cigarette	papers, is amende	d to read as follows:	
29	(b) It shall be unlawful for	any person under	eighteen (18) years of	
30	age:			
31	(1) To use or possess,	unless acting as	an agent of the minor's	
32	employer within the scope of employ	ment:		
33	(A) Tobacco in a	ny form; or		
34	(B) Cigarette pa	pers;		
35	(2) To purchase or att	empt to purchase:		
36	(A) Tobacco in a	nv form: or		

1	(b) Cigarette papers; or		
2	(3) For the purpose of obtaining or attempting to obtain tobacco		
3	in any form or cigarette papers, to:		
4	(A) Use any falsified identification; or		
5	(B) Use any identification other than his or her own.		
6	(4) To receive from any public or private package delivery		
7	service tobacco in any form or cigarette papers.

9	SECTION 3. Arkansas Code § 5-27-227(e), regarding providing minors		
10	with tobacco products and cigarette papers, is amended to read as follows:		
11	(e)(1) Any person who sells tobacco in any form or cigarette papers		
12	shall have the right to deny the sale of any such tobacco in any form or		
13	cigarette papers to any person.		
14	(2) Any person who delivers tobacco in any form or cigarette		
15	papers shall have the right to deny the delivery of a package containing		
16	tobacco or cigarette papers to any person.		
17			
18	SECTION 4. Arkansas Code § 5-27-227, regarding providing minors with		
19	tobacco products and cigarette papers, is amended to add an additional		
20	subsection to read as follows:		
21	(o)(1) An employee or agent of a public or private package delivery		
22	service who knowingly delivers tobacco in any form or cigarette papers to a		
23	person under the age of eighteen (18) shall be guilty of a violation and		
24	subject to the following penalties:		
25	(A) If the alleged violator received a notice of an		
26	alleged violation from the Arkansas Tobacco Control Board or other agency or		
27	official with the authority to assess penalties under this section, a fine		
28	not to exceed one hundred dollars ( $\$100$ ) for a first violation within a		
29	forty-eight (48) month period;		
30	(B) A fine not to exceed two hundred dollars (\$200) for a		
31	second violation within a forty-eight (48) month period;		
32	(C) A fine not to exceed three hundred dollars (\$300) for		
33	a third violation within a forty-eight (48) month period;		
34	(D) A fine not to exceed four hundred dollars (\$400) for a		
35	fourth violation within a forty-eight (48) month period; and		
36	(E) A fine not to exceed five hundred dollars (\$500) for a		

1	litth violation and any additional violations within a forty-eight (48) month
2	period.
3	(2) Any tobacco product accepted for delivery by a public or
4	private delivery service in this state shall contain a clear and visible
5	label with the following notice in red lettering at least one-half inch
6	(1/2") high on white background: "THIS PACKAGE CONTAINS TOBACCO PRODUCTS OR
7	CIGARETTE PAPERS AND REQUIRES THE SIGNATURE OF A PERSON EIGHTEEN (18) YEARS
8	OLD OR OLDER TO LAWFULLY RECEIVE IT."
