12	SECTION 2. Arkansas Code § 6-20-402(b)(1)(A), regarding debt		
13	obligation of school, is amended to read as follows:		
14	(b)(1)(A) Postdated Except as provided in subdivision (b)(1)(B) of		
15	this subsection, postdated warrants, lease purchase agreements, and		
16	installment contracts must be paid within ten (10) years of the date of		
17	issuance of the postdated warrant or the execution of the written lease		
18	purchase agreement or installment contract, as the case may be.		
19	(B) Long-term lease agreements allowed under subdivision		
20	(a)(2)(E)(ii) must be paid within thirty (30) years of the date of the		
21	execution of the written lease purchase agreement.		
22	(C) Postdated warrants, lease purchase agreements, and		
23	installment contracts must be registered, on forms provided by the State		
24	Board of Education, with the treasurer of the district and the board.
