19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. Arkansas Code § 16-13-2801 is amended to read as follows:  
22 16-13-2801. Composition.

23 The Twentieth Judicial District shall be composed of the counties of  
24 Faulkner ~~Searey~~, and Van Buren.  
25

26 SECTION 2. Arkansas Code § 16-13-2802 is amended to read as follows:  
27 16-13-2802. Terms of court.

28 The terms of court in each county in the Twentieth Judicial District  
29 shall commence on the dates set forth below:

30 (1) Faulkner County: On the first Monday in May and the first  
31 Monday in December;

32 ~~(2) Searey County: On the third Mondays in April and October;~~

33 ~~(3)~~(2) Van Buren County: On the first Mondays in May and  
34 November.

36 SECTION 3. Arkansas Code § 16-13-2804 is amended to read as follows:



1 16-13-2804. Responsibility for expenses.

2 (a) In lieu of any other expenses incurred by each court provided by  
3 law for the Twentieth Judicial District, each county of the circuit shall be  
4 responsible for the following amounts:

5 ~~(1) Searcy County ..... One thousand five hundred dollars~~  
6 ~~(\$1,500);~~

7 ~~(2)(1) Van Buren County ..... Five hundred dollars (\$500); and~~

8 ~~(3)(2) Faulkner County ..... All other expenses not otherwise~~  
9 provided for by law.

10 (b) Nothing herein shall be construed to prevent the respective quorum  
11 courts of the counties in the district from paying more than the amounts set  
12 forth herein.

14 SECTION 4. Arkansas Code § 16-13-2201 is amended to read as follows:  
15 16-13-2201. Composition.

16 The Fourteenth Judicial District shall be composed of the counties of  
17 Baxter, Boone, Marion, Searcy, and Newton.

19 SECTION 5. Arkansas Code § 16-13-2202 is amended to read as follows:  
20 16-13-2202. Terms of court.

21 The terms of court in each county in the Fourteenth Judicial District  
22 shall commence on the dates set forth below:

23 (1) Baxter County: On the second Monday in March and the second  
24 Monday in September;

25 (2) Boone County: On the third Monday in April and the third  
26 Monday in October;

27 (3) Newton County: On the first Mondays in March and September;

28 (4) Marion County: On the first Mondays in April and October;

29 (5) Searcy County: On the third Mondays in April and October.
