18	obtain a judgment for the amount of any fine imposed according to its
19	authority.
20	(B) The action by the court shall not involve further
21	judicial review of the board's actions.
22	(C) The fee normally charged for the filing of a suit in

24	waived on behalf of the board.
25	(3) All moneys received by the board in payment of fines shall
26	be deposited in the State Treasury as general revenues.
27	(f)(l) The board shall complete its investigation of a complaint filed
28	according to this section and take final action within one hundred eighty
29	(180) days of the filing of the complaint.
30	(2) However, if a hearing under subdivision (c)(l) of this
31	section is conducted, all action on the complaint by the board shall be
32	completed within two hundred forty (240) days.
33	(3) Any final action of the board under this section shall
34	constitute an adjudication for purposes of judicial review under § 25-15-212.
35	(g)(l) The board shall keep a record of all inquiries, investigations,
36	and proceedings.

1	(2) Records relating to investigations by the board are exempt
2	from the Freedom of Information Act of 1967, until a hearing is set or the
3	Director's investigation is closed.
4	(3) The board may, through its members or staff, disclose
5	otherwise confidential information to proper law enforcement officials,
6	agencies, and bodies as may be required to conduct its investigation.
