9 AN ACT TO AMEND THE ARKANSAS TELECOMMUNICATIONS
10 REGULATORY REFORM ACT TO EXCLUDE CHARGES FOR
11 EXTENDED AREA SERVICES IN DETERMINING RATE

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
23

24 *SECTION 1. Arkansas Code § 23-17-412(i)(1), concerning rate increases*
25 *for non-tier one rural telephone companies, is amended to read as follows:*

26 *(i)(1) The commission on its own motion may review basic local*
27 *exchange service rates of any company subject to this section if the company*
28 *has increased the rates by more than the greater of fifteen percent (15%) or*
29 *two dollars (\$2.00) per access line per month within any consecutive twelve-*
30 *month period, excluding rate increases ordered by the commission pursuant to*
31 *§ 23-17-404 or rate increases resulting from the provision of extended area*
32 *services required as the result of customer election under commission rules.*
33

34 *SECTION 2. Arkansas Code § 23-17-407(b)(1), concerning regulation of*
35 *rates for basic local exchange service and switched access service of*
36 *electing companies, shall be amended to read as follows:*



1 (b)(1) After the expiration of the three year period, the rates for
2 basic local exchange services and switched-access services, excluding the
3 intrastate carrier common line charge, may be adjusted by the electing
4 company filing a price list with the commission, as long as the rates remain
5 at or below the inflation-based rate cap or the rate increase results from
6 the provision of extended area services required as the result of customer
7 election under commission rules.

9 SECTION 3. Arkansas Code Title 23, Chapter 17, Subchapter 4, is
10 amended to add a new section read as follows:

11 23-17-414. Extended area service.

12 (a) The commission shall promulgate rules that enable customers in a
13 local exchange service area to petition the commission directly, or by a
14 resolution of the customers' quorum court or other local governing body, to
15 request that an ILEC provide extended area service.

16 (b)(1) The rules relating to the provision of extended area shall
17 include:

18 (A) The procedure by which customers may petition the
19 commission for an election on the provision of extended area service;

20 (B) The information required for the commission to verify
21 that the rate to be charged for providing extended area service will be just
22 and reasonable;

23 (C) Notice requirements to customers regarding the rate,
24 terms, and conditions under which extended area service would be provided as
25 a result of a scheduled election under subsection (a) of this section; and

26 (D) The procedure for conducting an election under
27 subsection (a) of this section, and for determining whether extended area
28 service will be provided as a result of the election.

29 (2) After the initial election and adoption of extended area
30 service, no subsequent change in the rate charged for the provision of
31 extended area service shall be effective unless adopted under the
32 commission's rules promulgated to implement this section.

33 (c) If the affected customers vote in favor of instituting or renewing
34 extended area service under this section, the carrier shall implement
35 extended area service at a rate that is consistent with subdivision (b)(1)(B)
36 of this section.
