9 AN ACT TO AMEND ARKANSAS CODE TITLE 27, CHAPTER
10 15 TO ADD AN ADDITIONAL SUBCHAPTER TO PROVIDE FOR
11 THE ISSUANCE OF AN ORGAN DONOR AWARENESS SPECIAL
12 LICENSE PLATE TO PROVIDE CONTRIBUTIONS FOR THE
13 ORGANIZATION; AND FOR OTHER PURPOSES.

15 TO PROVIDE FOR THE ISSUANCE OF AN ORGAN
16 DONOR AWARENESS SPECIAL LICENSE PLATE TO
17 PROVIDE CONTRIBUTIONS FOR THE

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
23

24 SECTION 1. Arkansas Code Title 27, Chapter 15, is amended to add an
25 additional subchapter to read as follows:

26 Subchapter 39 - Organ Donor Awareness License Plate

28 27-15-3901. Organ Donor Awareness license plate authorized.

29 The Director of the Department of Finance and Administration shall
30 provide for and issue Organ Donor Awareness special license plates in the
31 manner and subject to the conditions under this subchapter.

33 27-15-3902. Plate design.

34 (a)(1) The special motor vehicle license plates shall be designed by
35 the Arkansas Regional Organ Recovery Agency.

36 (2) The design shall be submitted for design approval by the



1 Director of the Department of Finance and Administration under rules and
2 regulations of the director.

3 (3) The Arkansas Regional Organ Recovery Agency may periodically
4 submit a newly designed license plate for approval and issue by the director,
5 with not more than one (1) license plate new design issued per calendar year.

6 (b)(1) Upon approval of the design by the director, the Arkansas
7 Regional Organ Recovery Agency shall remit to the department a fee in the
8 amount of six thousand dollars (\$6,000) to cover the cost of the initial
9 order of each newly designed license plate.

10 (2) This fee shall be deposited to the State Central Services
11 Fund for the benefit of the Revenue Services Division of the Department of
12 Finance and Administration and shall be credited as supplemental and in
13 addition to all other funds as may be deposited for the benefit of the
14 division.

15 (3) The fee shall not be considered or credited to the division
16 as direct revenues.

17 (c) The director shall promulgate reasonable rules and regulations and
18 prescribe any forms as the director determines to be necessary to carry out
19 the intent and purposes of this subchapter.

20
21 27-15-3903. Transfer to another vehicle.

22 Special Organ Donor Awareness license plates issued under this
23 subchapter may be transferred from one vehicle to another under § 27-14-914.

25 27-15-3904. Compliance with other laws.

26 The special Organ Donor Awareness license plates shall comply with all
27 other state motor vehicle laws relating to registration and licensing of
28 motor vehicles, including the minimum number of license plate applications
29 required under § 27-15-4004, except as specifically provided otherwise in
30 this subchapter.
