10 AN ACT TO AMEND ARKANSAS CODE § 16-13-506 TO  
11 ALLOW COURT REPORTERS TO INCREASE FEES FOR ALL  
12 CIVIL TRANSCRIPTS AND TO CHARGE ADDITIONAL FEES  
13 FOR EXPEDITED TRANSCRIPTS AT A HIGHER RATE THAN  
14 FOR TRANSCRIPTS; AND FOR OTHER PURPOSES.

17 AN ACT TO ALLOW COURT REPORTERS TO  
18 INCREASE FEES FOR ALL CIVIL TRANSCRIPTS.

21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
22

23 SECTION 1. Arkansas Code § 16-13-506(a)(1), concerning court  
24 reporter's transcript fees, is amended to read as follows:

25 (a)(1) When required to make a transcript of court proceedings, each  
26 court reporter of the circuit ~~and chancery courts~~ court shall be entitled to  
27 compensation for: ~~at the rate of three dollars and ten cents (\$3.10) per page~~  
28 ~~for the original and two (2) copies and at the rate of fifty cents (50¢) per~~  
29 ~~page for each additional copy~~

30 (A) An original transcript at the rate of three dollars  
31 and thirty cents (\$3.30) per page for the original, eighty-three cents (83¢)  
32 per page for the first copy, and fifty-five cents (55¢) per page for each  
33 additional copy;

34 (B) An expedited transcript at the rate of four dollars  
35 and forty cents (\$4.40) per page for the original, eighty-three cents (83¢)  
36 per page for the first copy, and fifty-five cents (55¢) per page for each



1 additional copy;

2 (C) A daily transcript at the rate of five dollars and  
3 fifty cents (\$5.50) per page for the original, one dollar and ten cents  
4 (\$1.10) per page for the first copy, and eighty-three cents (83¢) per page  
5 for each additional copy; and

6 (D) An hourly transcript at the rate of six dollars and  
7 sixty cents (\$6.60) per page for the original, one dollar and ten cents  
8 (\$1.10) per page for the first copy, and eighty-three cents (83¢) per page  
9 for each additional copy;
