19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
20

21 SECTION 1. (a)(1) Notwithstanding any other provision of law, it
22 shall be unlawful for any person to knowingly possess one ounce (1 oz.) or
23 less of marijuana or tetrahydrocannabinols.

24 (2) Any person who pleads guilty or nolo contendere to, or is
25 found guilty of violating subsection (a)(1) of this section shall be
26 imprisoned for no less than twenty-four hours and no more than one (1) year,
27 except that the court may order public service in lieu of jail, and shall be
28 fined not less than one hundred fifty dollars (\$150) and no more than one
29 thousand dollars (\$1000).

30 (3) Any person who pleads guilty or nolo contendere to, or is
31 found guilty of violating subsection (a)(1) of this section for the second
32 offense occurring within five (5) years of the first offense, shall be
33 imprisoned for no fewer than seven (7) days but no more than one (1) year or
34 no fewer than thirty (30) days of community service, and shall be fined no
35 less than four hundred dollars (\$400) and no more than three thousand dollars
36 (\$3,000).



(4) Any person who pleads guilty or nolo contendere to, or is found guilty of violating subsection (a)(1) of this section for a third offense occurring within five (5) years of the first offense shall be imprisoned for no fewer than ninety (90) days but no more than one (1) year or no fewer than ninety (90) days of community service, and shall be fined no less than nine hundred dollars (\$900) and no more than five thousand dollars (\$5,000).

(5) Any person who pleads guilty or nolo contendere to, or is found guilty of violating subsection (a)(1) of this section for a fourth or subsequent offense occurring within five (5) years of the first offense shall be imprisoned for at least one (1) year but no more than six (6) years or not less than one (1) year of community service, and shall be fined no more than ten thousand dollars (\$10,000), and shall be guilty of an unclassified felony.

(b) Any person who unlawfully possesses more than one ounce (1 oz.) of marijuana or tetrahydrocannabinols shall be punished as provided under the Uniform Controlled Substances Act, § 5-64-101 et seq.

SECTION 2. Arkansas Code § 16-10-305(a) is amended to add an additional subdivision to read as follows:

"(8)(A) For knowingly possessing one ounce (1 oz.) or less of marijuana or tetrahydrocannabinols in circuit, district or city court, three hundred dollars (\$300).

(B) Two hundred dollars (\$200) of the court costs collected under this subdivision (8) shall be remitted to the Treasurer of State by the court clerk for deposit in the MAGNUM Drug Court Fund which is a special revenue fund created and established on the books of the Treasurer of State, Auditor of State, and Chief Fiscal Officer of the State.
