25	20-27-1701. Pur	pose.	
26	The purpose of §	§ 20-27-701 through 20-27-709 is	to protect the health
27	of the citizens of Arka	ansas by establishing a ban on the	e smoking of tobacco
28	products in food servi	ce establishments in Arkansas to e	ensure that patrons
29	and employees of food	service establishments in Arkansas	s are not subjected to
30	the harmful effects of	tobacco smoke.

32	20-27-1702. Def:	<u>initions.</u>	
33	For the purposes	of §§ 20-27-704 through 20-27-709	9 <b>:</b>
34	(1)(A) "Bar" mea	ans an establishment that:	
35	<u>(i)</u>	Has more than seventy percent (70	0%) of its annual
36	gross sales in alcohol:	ic beverages:	

1	(ii) Is devoted to serving alcoholic beverages for		
2	consumption by guests on the premises;		
3	(iii) In which the serving of food is only incidental to		
4	the consumption of alcoholic beverages; and		
5	(iv) From which minors are refused admittance unless		
6	accompanied by a parent or legal guardian;		
7	(B) "Bar" does not include food service establishments that		
8	contain a bar merely because minors are admitted in these areas.		
9	(2) "Department" means the Department of Health;		
10	(3) "Employee" means a person who is employed by an employer for		
11	direct or indirect monetary wages or profit, and any person who volunteers		
12	his or her services for a profit or non-profit entity;		
13	(4) "Employer" means a person, partnership, corporation, municipal		
14	corporation, non profit entity, or entity that employs the services of one		
15	(1) or more individual persons;		
16	(5) "Enclosed area" means an area closed in by a roof and walls with		
17	appropriate openings for ingress and egress;		
18	(6) "Food" means any raw, cooked or processed edible substance, ice,		
19	beverage, or ingredient used or intended for use or for sale in whole or in		
20	part for human consumption;		
21	(7)(A) "Food service establishment" means any place where food is		
22	manufactured, packaged, produced, processed, transported, stored, sold,		
23	commercially prepared, vended, or otherwise handled.		
24	(B) "Food service establishment" includes, but it not limited		
25	to:		
26	<pre>(i) Coffee shops;</pre>		
27	(ii) Cafeterias;		
28	(iii) Sandwich shops;		
29	(iv) Catering facilities; and		
30	(v) Any other eating establishment that gives or offers		
31	food to the public, guests, or employees.		
32	(C) "Food service establishment" does not include:		
33	(i) Cocktail lounges or taverns if the cocktail lounge or		
34	tavern is a bar; or		
35	(ii) Private homes where food is prepared or served for		
36	guests and individual family consumption;		

1	(8) "Minor" means any person under eighteen (18) years of age;		
2	(9) "Person" means any individual, partnership, corporation,		
3	association or venture;		
4	(10) "Smoking" means inhaling, exhaling, burning, or carrying any		
5	lighted, tobacco product, weed, plant, or other combustible substance; and		
6	(11) "Tobacco Product" means any tobacco, cigarette, cigar, pipe		
7	tobacco, smokeless tobacco, snuff or any other form or tobacco, that may be		
8	used for smoking, chewing, inhaling, or other manner of ingesting or		
9	absorbing into the body.

11	20-27-1703. Food service establishments.		
12	(a) Thirty (30) days after the effective date of this subchapter,		
13	smoking shall be prohibited in all food service establishments that earn more		
14	than thirty percent (30%) of their gross revenue from food sales.		
15	(b) The prohibition against smoking applies to all enclosed areas to		
16	which patrons have general access, including, but not limited to:		
17	(1) Dining areas;		
18	(2) Food order areas;		
19	(3) Food service areas;		
20	(4) Restrooms; and		
21	(5) Cashier areas.		
22	(c) A food service establishment owner or operator violates this		
23	subchapter if a person is allowed to smoke or possess a burning tobacco		
24	product, weed, or other plant product in an area of a food service		
25	establishment designated as a non-smoking area.		
26			
27	20-27-1704. Posting of signs.		
28	(a)(1) Each food service establishment shall post appropriate signs		
29	visible to patrons within the dining area indicating that the smoking of		
30	tobacco products, weed, or other plant product is prohibited in the area.		
31	(2) The sign required in subdivision (a)(1) is not required if		
32	all patrons of the food establishment are seated by a host or hostess who		
33	advises them that smoking is prohibited.		
34	(b) Signs bearing the words "No Smoking" or the international "No		
35	Smoking" symbol, consisting of the pictorial representation of a burning		
36	cigarette enclosed in circle with a bar across it, shall be clearly and		

1	conspicuously displayed at every entrance of every food service establishmen
2	in which smoking is prohibited under this subchapter.
3	
4	20-27-1705. Public education.
5	The Department of Health shall develop an educational program to
6	explain the purpose and requirements of this subchapter to businesses and
7	citizens affected by it and to help persons, owners, operators, and managers
8	comply with this subchapter.
9	
10	20-27-1706. Penalties.
11	(a) Each violation of this subchapter is a Class A misdemeanor.
12	(b) Each day a violation exists or continues shall constitute a
13	separate offense.
