19	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21	SECTION 1. Arkansas Code § 6-42-201(a) and (b), concerning the	
22	establishment of the Arkansas School for Mathematics and Sciences, is	amended
23	to read as follows:	
24	(a) There is hereby established the Arkansas School for Mathema	tics
25	and Sciences, and the Arts, hereinafter "school", which shall be a	
26	residential school for eleventh and twelfth grade students.	
27	(b)(1) The purposes of the school shall be to educate the gifte	d and
28	talented math, and science, and fine and performing arts students of t	he
29	state and to develop curricula and materials to improve instruction in	Ĺ
30	mathematics, and sciences, and fine and performing arts for all studen	ts in
31	the state. The school's curriculum, faculty, and admissions policy sha	.11
32	reflect those purposes.	
33	(2) While the emphasis of the school shall be dedicated t	o the
34	academic teaching of mathematics, and sciences, and fine and performin	g arts,
35	some emphasis may be placed on the arts and humanities as deemed appro	priate
36	by the board of trustees.

2	SECTION 2. Arkansas Code § 6-42-202 is amended to read as follows:
3	6-42-202. Board of trustees.
4	(a) The school shall be governed by a board of trustees.
5	(b)(1)(A) The board of trustees shall consist of seven (7) members,
6	with one (1) member appointed from each congressional district and the
7	remaining members appointed at large.
8	(B) The Governor shall appoint all seven (7) members of
9	the board of trustees.
10	(C) Members of the board appointed by the Governor under
11	the provisions of this section, in addition to possessing the qualifications
12	of an elector, shall reside in the State of Arkansas.
13	(2)(A) Five (5) $\underline{\text{Six (6)}}$ ex officio nonvoting members shall also
14	serve on the board.
15	(B) The Director of the Department of Education, the
16	Director of the Department of Higher Education, the President of the Arkansas
17	Science and Technology Authority, the Director of the Department of Arkansas
18	Heritage, the president of the school's parent association, and the president
19	of the school's student government shall serve as the $\frac{\text{five (5)}}{\text{six (6)}}$ ex
20	officio, nonvoting members of the board.
21	(c) Members shall serve seven-year terms.
