- 10 this pay increase after their probationary period expires, provided the above
- 11 requirements are met. Employees possessing or obtaining the pay increase
- 12 authorized herein shall not be eligible for a second incentive increase upon
- 13 obtaining a second professional certification from the Wildlife Society or
- 14 The American Fisheries Society. Employees being compensated at the maximum
- of their assigned grade shall be eligible for the six percent (6%) increase
- 16 in a lump sum payment, and such payment shall not be construed as exceeding
- 17 the maximum salary for the grade.
- The provisions of this section shall be in effect only from July 1, 2001

        SECTION 14. EMERGENCY CLAUSE. It is found and determined by the General
```

Assembly, that the Constitution of the State of Arkansas prohibits the

1	appropriation of funds for more than a two (2) year period; that the
2	effectiveness of this Act on July 1, 2003 is essential to the operation of
3	the agency for which the appropriations in this Act are provided, and that in
4	the event of an extension of the Regular Session, the delay in the effective
5	date of this Act beyond July 1, 2003 could work irreparable harm upon the
6	proper administration and provision of essential governmental programs.
7	Therefore, an emergency is hereby declared to exist and this Act being
8	necessary for the immediate preservation of the public peace, health and
9	safety shall be in full force and effect from and after July 1, 2003.
