1 2 SECTION 11. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. 3 4 PROFESSIONAL CERTIFICATION. The Arkansas Game and Fish Commission is hereby 5 authorized, after prior review by the Arkansas Legislative Council, to grant 6 a six percent (6%) increase to any regular salaried biologist serving in the 7 capacity of a forester, who possesses or acquires professional certification 8 from the Society of American Foresters and registration with the Arkansas 9 State Board of Registration for Foresters during the 2003-2005 biennium. 10 This pay increase will be awarded beginning with the first bi-weekly pay 11 period following submission of documented proof of such certification and 12 registration to the Commission Personnel Office, provided the biologist's 13 most recent performance evaluation results in a satisfactory rating. Biologists not obtaining a satisfactory performance evaluation rating will be 14 15 granted the pay increase on their next eligibility date, provided their new evaluation is satisfactory. New employees and probationary employees shall 16 17 be eligible for this pay increase after their probationary period expires, provided the above requirements are met. Employees being compensated at the 18 maximum of their assigned grade shall be eligible for the six percent (6%) 19 increase in a lump sum payment, and such payment shall not be construed as 20 exceeding the maximum salary for the grade. 21 The provisions of this section shall be in effect only from July 1, 2003 22 23 through June 30, 2005. 24 25 SECTION 12. LEGISLATIVE INTENT. It is the intent of the General Assembly 26 that any funds disbursed under the authority of the appropriations contained 27 in this act shall be in compliance with the stated reasons for which this act 28 was adopted, as evidenced by the Agency Requests, Executive Recommendations 29 and Legislative Recommendations contained in the budget manuals prepared by 30 the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or 31 32 Joint Budget Committee which relate to its passage and adoption. 33 SECTION 13. EMERGENCY CLAUSE. It is found and determined by the General 34 35 Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a two (2) year period; that the 36

1	effectiveness of this Act on July 1, 2003 is essential to the operation of
2	the agency for which the appropriations in this Act are provided, and that in
3	the event of an extension of the Regular Session, the delay in the effective
4	date of this Act beyond July 1, 2003 could work irreparable harm upon the
5	proper administration and provision of essential governmental programs.
6	Therefore, an emergency is hereby declared to exist and this Act being
7	necessary for the immediate preservation of the public peace, health and
8	safety shall be in full force and effect from and after July 1, 2003.
