For An Act To Be Entitled

9 AN ACT TO AMEND ARKANSAS CODE TITLE 24, CHAPTER
10 4, SUBCHAPTER 5 TO ADD A NEW SECTION TO ALLOW
11 MEMBERS OF THE PUBLIC EMPLOYEES' RETIREMENT
12 SYSTEM TO PURCHASE SERVICE CREDIT FOR SERVICE IN
13 THE ARKANSAS NATIONAL GUARD OR THE ARMED FORCES
14 RESERVE; AND FOR OTHER PURPOSES.

17 TO ALLOW PERS MEMBERS TO PURCHASE
18 SERVICE CREDIT FOR TIME IN THE NATIONAL
19 GUARD OR ARMED FORCES RESERVE.

23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
24

25 SECTION 1. Arkansas Code Title 24, Chapter 4, Subchapter 5 is amended
26 to add an additional section to read as follows:

27 24-4-524. Arkansas National Guard and Armed Forces Reserve service
28 credit.

29 (a) As used in this section, "Armed Forces Reserve" means one of the
30 Reserve components of the United States armed forces.

31 (b)(1) A member of the Public Employees' Retirement System is entitled
32 to purchase credited service in the system for a period not to exceed five
33 (5) years for compensated service rendered by the member in the Arkansas
34 National Guard or in the Armed Forces Reserve if the member:

35 (A) Makes an application to the Board of Trustees of the
36 Public Employees' Retirement System;



1 (B) Provides the board with satisfactory proof of that
2 person's service in the Arkansas National Guard or Armed Forces Reserve; and

3 (C)(i) For each year of service credit granted, pays to
4 the system the employee and employer contributions based on the greater of:

5 (a) The annual salary received by the member
6 for the member's first full year of credited service that precedes the fiscal
7 year in which the service is purchased; or

8 (b) The average of the three (3) highest
9 salaries earned at the time of purchase; and

10 (ii) Interest from the end of that year of credited
11 service to the date of payment in full.

12 (2) Payments for service under this section are to be based on
13 the contribution rates in effect at the time of the purchase.

14 (3) If the payment for service under this section is not made in
15 a single lump-sum payment, interest shall accrue from the date of the initial
16 payment to the date of the payment in full.

17 (4) The payment is to be credited to the member's account in the
18 members' deposit account and is in addition to any regular member
19 contributions.

20 (c) Members shall receive one (1) year of purchased service credit for
21 each five (5) years of compensated service in the Arkansas National Guard or
22 in the Armed Forces Reserve.

23 (d) The Arkansas National Guard or Armed Forces Reserve service shall
24 not become credited service under this system until:

25 (1) The member pays for all the Arkansas National Guard or Armed
26 Forces Reserve service, or a portion of the service in one (1) year
27 increments, at one (1) time in a single lump-sum payment; and

28 (2) The member has established five (5) or more years of actual
29 service in the system.

30 (e) If a member ceases to be an active member before the Arkansas
31 National Guard or Armed Forces Reserve service has been established as
32 system-credited service, the member payments contributed under this section
33 are refundable, together with regular interest.

34 (f)(1) This section is supplemental to § 24-2-502, and nothing in this
35 section shall diminish the right of any member of the system to obtain
36 credited service in the system for active duty military service within the

1 limits permitted by § 24-2-502.

2 (2)(A) However, no member is entitled to receive in excess of
3 five (5) years of credited service rendered by the member under this section;

4 (B) No member is eligible to purchase service credit in
5 more than one (1) state-supported retirement system for service time in the
6 Arkansas National Guard or in the Armed Forces Reserve;

7 (C) Service credit in the system for active duty military
8 service under § 24-2-502 and for service in the Arkansas National Guard or
9 Armed Forces Reserve shall not be given for the same period of time; and

10 (D) The service is not credited as service under any other
11 retirement system, including federal systems, except social security.
