21	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

It is found and determined by the General Assembly that there is an urgent need for additional funding for public education, prisons, health care, and other essential government services; that every effort must be made to use current resources as efficiently and effectively as possible to provide the maximum possible funding for these essential government services; that there are significant opportunities for savings in the cost of operating state government by combining offices and eliminating duplicate functions; that this act is designed to reorganize the executive branch of Arkansas state government and

1	elimination of duplicate administrative functions; that the consolidation
2	will reduce the administrative costs of operating state government and allow
3	additional current resources to be used to fund public education, prisons,
4	health care, and other essential government services. Therefore, an
5	emergency is declared to exist and this act being necessary for the
6	preservation of the public peace, health and safety shall become effective
7	<u>on</u> :
8	(1) The date of its approval by the Governor;
9	(2) If the bill is neither approved nor vetoed by the Governor, the
10	expiration of the period of time during which the Governor may veto the bill;
11	<u>or</u>
12	(3) If the bill is vetoed by the Governor and the veto is overridden.
