1 2 SECTION 2. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. 3 4 DISBURSING RESTRICTIONS. Before funds in this appropriation can be disbursed, 5 the Arkansas Sports Hall of Fame must certify to the Chief Fiscal Officer of 6 the State the procurement of two million dollars (\$2,000,000) for the purpose 7 of operations of the Arkansas Sports Hall of Fame facility. 8 The provisions of this section shall be in effect only from July 1, 2003 9 through June 30, 2005. 10 11 SECTION 3. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor 12 obligations otherwise incurred in relation to the project or projects described herein in excess of the State Treasury funds actually available 13 therefor as provided by law. Provided, however, that institutions and 14 15 agencies listed herein shall have the authority to accept and use grants and 16 donations including Federal funds, and to use its unobligated cash income or 17 funds, or both available to it, for the purpose of supplementing the State Treasury funds for financing the entire costs of the project or projects 18 19 enumerated herein.
