5	SECTION 2. Arkansas Code § 14-14-917(a)(4), concerning the time of		
6	special elections for initiative and referendum elections, is amended to read		
7	as follows:		
8	(4) Time of Special Election. The county court shall fix the		
9	date for the conduct of any special elections on referendum measures. The		
10	date shall be not less than thirty (30) calendar days after the date of the		
11	order calling the election. However, where the electors exercise their powers		
12	to establish the necessity for a special election, the county court shall		
13	order an election not more than forty-five (45) calendar days after		
14	certification of sufficiency by the county clerk, nor according to the dates		
15	stated in § 7-5-103, but not less than thirty (30) calendar days after the		
16	date of the order calling the election.

18	SECTION 3. Arkansas Code § 6-14-102(d), concerning special school		
19	elections, is amended to read as follows:		
20	(d) The board of directors of any school district shall have the		
21	authority to request the county board of election commissioners to call a		
22	special election for the purpose of considering a rate of tax for additional		
23	millages for maintenance and operations or for debt service as authorized by		
24	Arkansas Constitution, Amendment 74, provided that:		
25	(1) All constitutional and statutory requirements for a special		
26	school election are met;—and		
27	(2) The date of the election is approved by the director \pm ; and		
28	(3) The special election is held on the second Tuesday of any		
29	month.

31	SECTION 4. Arkansas Code § 6-14-105 is amended to read as follows:		
32	6-14-105. Special election on petition of school district board of

34	(a) If the board of directors of a school district deems it advisable		
35	to hold a special election in the district, the board of directors shall		
36	present a petition to the county court of the county of its domicile.		

1	(b) (1) If the county court approves of the petition, it shall enter an
2	order fixing a day for the special election, not earlier than thirty (30)
3	days after the date of the order.
4	(2) The county court shall set the date for the special election
5	so that the special election is held on the second Tuesday of any month.
