24 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

26 SECTION 1. REGULAR SALARIES - NORTH CENTRAL AREA HEALTH EDUCATION CENTER.
27 There is hereby established for the University of Arkansas for Medical
28 Sciences - North Central Area Health Education Center for the 2003-2005
29 biennium, the following maximum number of regular employees whose salaries
30 shall be governed by the provisions of the Uniform Classification and
31 Compensation Act (Arkansas Code §§21-5-201 et seq.), or its successor, and
32 all laws amendatory thereto. Provided, however, that any position to which a
33 specific maximum annual salary is set out herein in dollars, shall be exempt
34 from the provisions of said Uniform Classification and Compensation Act. All
35 persons occupying positions authorized herein are hereby governed by the
36 provisions of the Regular Salaries Procedures and Restrictions Act (Arkansas



Code §21-5-101), or its successor.

SECTION 2. APPROPRIATION - NORTH CENTRAL AREA HEALTH EDUCATION CENTER.

There is hereby appropriated, to the University of Arkansas for Medical Sciences, to be payable from the University of Arkansas Medical Center Fund, for personal services of the University of Arkansas for Medical Sciences - North Central Area Health Education Center for the biennial period ending June 30, 2005, the following:

SECTION 3. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by this act shall be limited to the appropriation for such agency and funds made available by law for the support of such appropriations; and the restrictions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures and Restrictions Act, the Higher Education Expenditures Restrictions Act, or their successors, and other fiscal control laws of this

1 State, where applicable, and regulations promulgated by the Department of
2 Finance and Administration, as authorized by law, shall be strictly complied
3 with in disbursement of said funds.

5 SECTION 4. LEGISLATIVE INTENT. It is the intent of the General Assembly
6 that any funds disbursed under the authority of the appropriations contained
7 in this act shall be in compliance with the stated reasons for which this act
8 was adopted, as evidenced by the Agency Requests, Executive Recommendations
9 and Legislative Recommendations contained in the budget manuals prepared by
10 the Department of Finance and Administration, letters, or summarized oral
11 testimony in the official minutes of the Arkansas Legislative Council or
12 Joint Budget Committee which relate to its passage and adoption.

14 SECTION 5. EMERGENCY CLAUSE. It is found and determined by the General
15 Assembly, that the Constitution of the State of Arkansas prohibits the
16 appropriation of funds for more than a two (2) year period; that the
17 effectiveness of this Act on July 1, 2003 is essential to the operation of
18 the agency for which the appropriations in this Act are provided, and that in
19 the event of an extension of the Regular Session, the delay in the effective
20 date of this Act beyond July 1, 2003 could work irreparable harm upon the
21 proper administration and provision of essential governmental programs.
22 Therefore, an emergency is hereby declared to exist and this Act being
23 necessary for the immediate preservation of the public peace, health and
24 safety shall be in full force and effect from and after July 1, 2003.
