21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

23 SECTION 1. Arkansas Code § 23-112-103(2), concerning the definitions
24 for the Arkansas Motor Vehicle Commission Act, is amended to read as follows:

25 (2) "All-terrain vehicle" means a motor vehicle which:

26 ~~(A) Is identified on a manufacturer's certificate or statement~~
27 ~~of origin containing a seventeen digit vehicle identification number;~~

28 ~~(B) Is designed primarily for nonhighway or all-terrain travel;~~

29 ~~(C) Travels on three (3) or more wheels;~~

30 (A)(i) Is an off-highway vehicle, fifty inches (50") or less in
31 width, having a dry weight of eight hundred pounds (800 lbs.) or less and
32 traveling on three (3) or more low pressure tires, with a seat designed to be
33 straddled by the operator, a Class 1 all-terrain vehicle; or

34 (ii) Is an off-highway vehicle with a width which exceeds
35 fifty inches (50") or having a dry weight that exceeds eight hundred pounds
36 (800 lbs.), traveling on four (4) or more low-profile, low-pressure tires and

1 having a bench seat, a Class 2 all-terrain vehicle;

2 ~~(D)~~(B) Has a seat for the operator and any passenger and
3 handlebars or other steering mechanism for control; and

4 ~~(E)~~(C) Is used for any purpose, including, but not limited to,
5 off-road, amphibious, or recreational travel;

7 SECTION 2. Arkansas Code § 23-112-103(18), concerning the definitions
8 for the Arkansas Motor Vehicle Commission Act, is amended to read as follows:

9 (18) "Motor vehicle" means any motor-driven vehicle having two (2) or
10 more wheels, including, but not limited to, all-terrain vehicles,
11 automobiles, trucks, motorcycles, motor-driven cycles, motor scooters, and
12 motor homes;
