1	(2) The design shall be submitted for design approval by the		
2	Director of the Department of Finance and Administration under rules and		
3	regulations of the director.		
4	(3) The Greek organization may periodically submit a newly		
5	designed license plate for approval and issue by the director, with not more		
6	than one (1) license plate new design issued per calendar year.		
7	(b)(1) Upon approval of the design by the director, the various Greek		
8	organizations shall remit to the department a fee in the amount of six		
9	thousand dollars (\$6,000) to cover the cost of the initial order of each		
10	newly designed license plate.
