5	(5) The expeditious reduction of emissions of air pollutants
6	that are ozone precursors is needed for certain areas of Arkansas to avoid a
7	nonattainment designation or minimize the amount of time it takes them to be

9	(6) The voluntary installation of control equipment at Arkansas

18	8-3-503. Definitions. For purposes of this subchapter:
19	(1) "Acquisition" means a transaction under which title to an
20	item is transferred for consideration, or a lease for a period of at least
21	three (3) years, regardless of whether title to the item is transferred at
22	the end of the period;
23	(2)(A) "Allowable costs" means those costs which are approved by
24	the department and derived directly from the installation and acquisition of
25	a vapor recovery system at a motor fuel dispensing facility.
26	(B) "Allowable costs" does not include expenditures for
27	land, feasibility studies, equipment used to service the vapor recovery
28	system, service contracts, sales tax, maintenance, and repair;
29	(3) "Commission" means the Arkansas Pollution Control and
30	Ecology Commission;
31	(4) "Department" means the Arkansas Department of Environmental
32	Quality;
33	(5) "Director" means the Director of the Arkansas Department of
34	Environmental Quality;
35	(6) "Distributor" means any person, including the State of
36	Arkansas and its political subdivision, but not including the United States

1	of America or its instrumentalities, except to the extent permitted by the
2	Arkansas Constitution or laws, who is customarily in the wholesale business
3	of offering motor fuels for resale or delivery to dealers, consumers, or
4	others in tanks of two hundred (200) gallons or more that are not connected
5	to motor vehicles and is:
6	(A) Making the first sale in the State of Arkansas of any
7	motor fuel, imported into the state from any state, territory, or foreign
8	country, after it has been received within this state within the meaning of
9	the Motor Fuel Tax Act, § 26-55-201 et seq.;
10	(B) Consuming or using in the State of Arkansas any motor
11	fuel imported from out of this state and who has purchased it before it has
12	been received by any other person in this state, within the meaning of the
13	Motor Fuel Tax Law, § 26-55-201 et seq.; or
14	(C) Producing, refining, preparing, distilling,
15	manufacturing, blending, or compounding motor fuel in this state;
16	(7) "Fund" means the Vapor Recovery System Fund created by this
17	subchapter;
18	(8)(A) "Motor fuel dispensing facility" means a stationary
19	facility that dispenses motor fuel to motor vehicles.
20	(B) "Motor fuel dispensing facility" does not include that
21	portion of a facility or operation that consists of a terminal;
22	(9) "Operator" means any person in control of, or having
23	responsibility for, the daily operation of the motor fuel dispensing
24	facility;
25	(10) "Owner" means any person who owns a motor fuel dispensing
26	facility;
27	(11) "Person" means any individual, corporation, company, firm,
28	partnership, association, trust, joint stock company or trust, venture,
29	municipal, state or federal government or agency, or any other legal entity;
30	(12) "Reasonable costs" means the costs or a range of costs
31	commensurate with the costs necessary to acquire and install a vapor recovery
32	system at a motor fuel dispensing facility, based upon an evaluation of
33	typical costs expected for the particular vapor recovery system that is being
34	acquired and installed;
35	(13)(A) "Supplier" means any person who is customarily in the
36	wholesale business of offering distillate special fuels or liquefied gas

1	special fuels for resale or use to any person in this state and who makes
2	bulk sales of fuel.
3	(B) "Supplier" includes pipeline importers, first
4	receivers, and second receivers;
5	(14) "Terminal" means a bulk storage facility for storing
6	petroleum products supplied by a pipeline or marine vessels; and
7	(15) "Vapor recovery system" means equipment used to capture
8	vapors associated with the transfer of motor fuel at a motor fuel dispensing
9	facility and generally denominated by applicable federal or Arkansas
10	regulations as:
11	(A) Stage one vapor recovery system, which is generally
12	applicable to the transfer of motor fuel from a transport tank into a
13	stationary storage tank; or
14	(B) Stage two vapor recovery system, which is generally
15	applicable to the transfer of motor fuel from the stationary storage tank
16	into a motor vehicle fuel tank.
17	
18	8-3-504. Rules and regulations - Powers of department.
19	(a) The Director of the Arkansas Department of Environmental Quality
20	may adopt appropriate rules and regulations not inconsistent with this
21	subchapter as the director may deem necessary to carry out the intent and
22	purpose of and to assure compliance with this subchapter.
23	(b) The Arkansas Pollution Control and Ecology Commission may adopt
24	appropriate rules and regulations not inconsistent with this subchapter to
25	carry out the intent and purposes of and assure compliance with this
26	subchapter.
27	(c) The department personnel may enter upon the property of any owner
28	or operator of a motor fuel dispensing facility to obtain information,
29	conduct surveys, or review records for the purpose of determining eligibility
30	for reimbursement for installation of vapor recovery systems at any time.
31	
32	8-3-505. Vapor Recovery System Trust Fund.
33	(a) There is created on the books of the Treasurer of State, the
34	Auditor of State, and the Chief Fiscal Officer of the State a fund to be
35	known as the "Vapor Recovery System Trust Fund".
36	(b) The fund shall be administered by the Director of the Arkansas

1	Department of Environmental Quality, who shall make disbursements from the
2	fund as authorized by this subchapter.
3	(c) The fund shall consist of gifts, grants, donations, and such other
4	funds as may be made available by the General Assembly, including all
5	interest earned upon money deposited in the fund, fees assessed under this
6	subchapter, and any other moneys legally designed for the fund.
7	(d) Moneys in the fund may be expended by the director solely for the
8	following purposes:
9	(1) To pay costs incurred by the Arkansas Pollution Control and
10	Ecology Commission and the director in the performance of their duties under
11	this subchapter; and
12	(2) To pay reimbursement to owners or operators of motor fuel
13	dispensing facilities for the acquisition and installation of vapor recovery
14	systems at certain motor fuel dispensing facilities as prescribed by this
15	subchapter.
16	(e) The liability or obligation of the fund is not the liability or
17	obligation of the State of Arkansas.
18	(f) Nothing in this subchapter shall be construed to abrogate or waive
19	the provisions of the Arkansas Constitution, Article 5 § 20.
20	(g)(1) Five (5) years after the effective date of this subchapter, the
21	fund shall no longer provide reimbursement for the acquisition and
22	installation of vapor recovery systems as prescribed in § 8-3-507 and the
23	fees collected shall be remitted to the counties in proportion to the rate of
24	collection from the counties to be used for transportation improvements
25	directly related to reducing motor vehicle emissions, including, but not
26	limited to, congestion relief measures, traffic signal coordination, traffic
27	management systems, air pollution reduction credit programs, ride sharing,
28	driver information, incident management, and public transit.
29	(2) Expenditures shall be based upon a plan agreed upon by the
30	county government, the municipalities in the county, the Arkansas State
31	Highway and Transportation Department, and in counties in metropolitan
32	statistical areas, the metropolitan planning organization.
33	
34	8-3-506. Ozone precursor reduction fee.
35	(a) Except as provided in subsection (d) of this section, there is
36	authorized an ozone precursor reduction fee of two cents (2¢) to be paid, on

1	each gallon of motor fuel or distillate special fuel purchased in or imported
2	into a county that has adopted an ordinance levying the fee.
3	(b) The commission may require that the ozone precursor reduction fee
4	be levied in all counties that it deems are contributing to the failure of
5	any county to meet the air quality standards for ozone as determined by the
6	United States Environmental Protection Agency, if through the normal
7	regulatory process the commission requires the installation of vapor recovery
8	systems at facilities that dispense motor fuel.
9	(c) The fee shall be paid by the first distributor or supplier
10	receiving fuel from a terminal in this state, or, if the fuel will never be
11	stored in a terminal in this state, then by the distributor or supplier who
12	first imports fuel into this state by tanker truck.
13	(d) Exchanges of fuels on a gallon for gallon basis within a terminal
14	or fuels exported from this state are exempt from the fee.
15	(e) Proof of payment shall be provided to the owner or operator.
16	(f) The fee shall be remitted to the Director of the Department of
17	Finance and Administration at the time, in the manner, and on forms
18	prescribed by the Director of the Department of Finance and Administration
19	and may be collected and remitted at the same time and in the same manner as
20	the motor fuels tax and special motor fuels tax under the Motor Fuel Tax law,
21	§ 26-55-201 et seq. and the Special Motor Fuels Tax Law, § 26-56-101 et seq.
22	(g) All fees shall be subject to collection and enforcement of
23	collection under the Arkansas Tax Procedure Act, § 26-18-101 et seq.
24	
25	8-3-507. Payment for acquisition and installation of vapor recovery
26	systems.
27	The fund shall reimburse an owner or operator of a motor fuel
28	dispensing system the allowable costs and reasonable costs for the
29	acquisition and installation of a vapor recovery system following proof that:
30	(1) The motor fuels dispensing system was constructed and in
31	operation prior to the effective date of this subchapter; and
32	(2) The motor fuel dispensing system is located in a county that
33	has levied the fee referenced in § 8-3-506; or
34	(3) The commission has promulgated a final regulation requiring
35	that motor fuel dispensing facilities install vapor recovery systems.

1	8-3-508. Procedures.
2	The procedures of the Arkansas Department of Environmental Quality and
3	the Arkansas Pollution Control and Ecology Commission for issuance of rules
4	and regulations, conduct of hearings, notice, power of subpoena, right of
5	appeal, presumptions, finality of actions, and related matters shall be as
6	provided in \$\$ 8-4-202, 8-4-210, 8-4-214, 8-4-218, 8-4-229 to the extent that
7	those statutes are not in conflict with the revisions of this subchapter.
8	
9	8-3-509. Audits.
10	(a) The Director of the Arkansas Department of Environmental Quality
11	may cause audits to be performed as necessary to ensure that the costs for
12	which reimbursement is sought or has been paid were incurred and necessary,
13	that the work was performed, and that reimbursement would be or is reasonable
14	and allowable.
15	(b) The audits may be performed by the department or by any qualified
16	person at the direction of the director.
17	(c) Moneys in the fund may be expended by the director as necessary to
18	pay the cost of audits performed by persons other than the department.
19	
20	8-3-510. Cost recovery.
21	The Arkansas Department of Environmental Quality may initiate
22	proceedings against any owner or operator for recovery of moneys that were
23	solicited or received from the fund, regardless whether it was approved by
24	the director, if the funds were solicited or received through willful or
25	accidental utilization of incorrect information, the work was not performed
26	or was unnecessary, or the equipment is not operable.
27	
28	8-3-511. Fund liability.
29	All claims for reimbursement submitted under the provisions of this
30	subchapter are subject to the availability of the moneys in the fund.
31	
32	8-3-512. Confidential treatment of information.
33	(a) Any records, reports, or information obtained by the Arkansas
34	Department of Environmental Quality or its employees in the administration of
35	this subchapter shall be kept confidential upon a showing satisfactory to the
36	Director of the Arkansas Department of Environmental Quality that the

T	records, reports, or information would constitute a trade secret under §§ 4-
2	75-601 through 4-75-607.
3	(b) As necessary to carry out the provisions of this subchapter,
4	information afforded confidential treatment may be transmitted under a
5	continuing claim of confidentiality to other officers or employees of the
6	state or of the United States if the owner or operator of the facility to
7	which the information pertains is informed of the transmittal and if the
8	information has been acquired by the department under the provisions of this
9	subchapter.
10	(c) The provisions of this section shall not be construed to limit the
11	department's authority to release confidential information during emergency
12	situations.
13	(d) Any violation of this section shall constitute an unclassified
14	misdemeanor.
15	
16	SECTION 2. Arkansas Code § 26-55-209 is amended to read as follows:
17	26-55-209. Local taxes prohibited.
18	No Except as provided in the Arkansas Vapor Recovery System Trust Fund
19	Act, §§ 8-3-501 et seq. no city, village, town, county, township, or other
20	subdivision or municipal corporation of this state shall levy or collect any
21	excise tax upon or measured by the sale, receipt, or distribution of motor
22	fuel.
