8 **SENATE CONCURRENT RESOLUTION**

9 TO PROVIDE FOR AN EXTENSION OF THE REGULAR
10 SESSION OF THE EIGHTY-FOURTH GENERAL ASSEMBLY
11 UNTIL MAY 12, 2003; RECESS ON APRIL 16; RECONVENE
12 ON APRIL 22; AND RECESS AT THE CLOSE OF BUSINESS
13 ON APRIL 25; TO PROVIDE THAT THE EIGHTY-FOURTH
14 GENERAL ASSEMBLY MAY BE CONVENED ON OR BEFORE MAY
15 12 TO CONSIDER VETOES, ERRORS, OMISSIONS, AND
16 CONSTITUTIONAL AMENDMENTS.

19 EXTEND THE REGULAR SESSION TO MAY 12,

24 BE IT RESOLVED BY THE SENATE OF THE EIGHTY-FOURTH GENERAL ASSEMBLY OF THE
25 STATE OF ARKANSAS, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN:

27 SECTION 1. The regular biennial session of the Eighty-Fourth General
28 Assembly is extended until the close of business on Monday, May 12, 2003.
29

30 SECTION 2. The General Assembly shall enter into recess at the close
31 of business on Wednesday, April 16, 2003, reconvene at 1 p.m. on Tuesday,
32 April 22, and recess at the close of business on Friday, April 25.

34 SECTION 3. The President Pro Tempore of the Senate and the Speaker of
35 the House of Representatives may, by joint proclamation, reconvene the
36 General Assembly at any time on or before May 12, 2003, for the purpose of



1 considering vetoes, correcting errors, oversights, and omissions and
2 completing its work on proposed constitutional amendments, including but not
3 limited to any constitutional amendment or amendments dealing with public
4 school finance which may be needed or required as a result of the Lake View
5 case.

7 SECTION 4. If the General Assembly is reconvened on or before May 12,
8 2003, as authorized in Section 3, then upon completion of the tasks for which
9 it was convened, it shall be adjourned sine die. If the General Assembly is
10 not reconvened or adjourned on or before May 12, 2003, the Regular Session of
11 the Eighty-Fourth General Assembly is adjourned sine die on that date.
