In the event the monies available in the Property 11 Sale Holding Fund are not adequate during any month of each year of the 12 fiscal biennium, to meet the payroll commitments of the Department of Finance and Administration - Management Services Division - Marketing and 13 14 Redistribution, for Regular Salaries and Personal Services Matching, the 15 Chief Fiscal Officer of the State is hereby authorized to make loans, from 16 time to time as needed, from the Budget Stabilization Trust Fund to the 17 Property Sale Holding Fund to provide the monies required to meet the payroll 18 and Personal Services Matching requirements for any such month. Provided 19 that, if, at the end of each fiscal year, the Property Sale Holding Fund did 20 not receive sufficient income to repay the entire amount of any such monies 21 borrowed from the Budget Stabilization Trust Fund for the purposes, as 22 authorized herein, the Chief Fiscal Officer of the State is hereby authorized 23 to transfer from the State Central Services Fund such amount as is necessary 24 to reimburse the Budget Stabilization Trust Fund in behalf of loans made to 25 the Property Sale Holding Fund to reimburse the Budget Stabilization Trust 26 Fund for the amount of any such loan remaining unpaid at the end of each 27 fiscal year.
