1 otherwise provided by the General Assembly for Maintenance and General 2 Operations of the agency or institutions receiving appropriation herein shall not be used for any of the purposes as appropriated in this act. 3 4 (B) The restrictions of any applicable provisions of the State Purchasing 5 Law, the General Accounting and Budgetary Procedures Law, the Revenue 6 Stabilization Law and any other applicable fiscal control laws of this State 7 and regulations promulgated by the Department of Finance and Administration, 8 as authorized by law, shall be strictly complied with in disbursement of any 9 funds provided by this act unless specifically provided otherwise by law. 10 11 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained 12 13 in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations 14 15 and Legislative Recommendations contained in the budget manuals prepared by 16 the Department of Finance and Administration, letters, or summarized oral 17 testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption. 18 19 20 SECTION 4. EMERGENCY CLAUSE. It is found and determined by the General 21 Assembly that funds provided by the General Assembly for the operations of 22 the Arkansas Department of Veterans' Affairs are, due to unforeseen 23 circumstances, insufficient for the Arkansas Department of Veterans' Affairs to continue to provide essential governmental services; that the provisions 24 of this act will provide the necessary monies for the Arkansas Department of 25 26 Veterans' Affairs to continue such services; and that a delay in the 27 effective date of this Act could work irreparable harm upon the proper 28 administration and provision of essential governmental programs. Therefore, 29 an emergency is hereby declared to exist and this Act being necessary for the 30 immediate preservation of the public peace, health and safety shall be in full force and effect from and after the date of its passage and approval. 31 32 If the bill is neither approved nor vetoed by the Governor, it shall become 33 effective on the expiration of the period of time during which the Governor may veto the bill. If the bill is vetoed by the Governor and the veto is 34 35 overridden, it shall become effective on the date the last house overrides 36 the veto.
