It is found and determined by the General 20 Assembly, that funds provided by the General Assembly for the operations of 21 the Arkansas State Claims Commission are, due to unforeseen circumstances, 22 insufficient for the Arkansas State Claims Commission to continue to provide 23 essential governmental services; that the provisions of this act will provide 24 the necessary monies for the Arkansas State Claims Commission to continue 25 such services; and that a delay in the effective date of this Act could work 26 irreparable harm upon the proper administration and provision of essential 27 governmental programs. Therefore, an emergency is hereby declared to exist 28 and this Act being necessary for the immediate preservation of the public 29 peace, health and safety shall be in full force and effect from and after the 30 date of its passage and approval. If the bill is neither approved nor vetoed by the Governor, it shall become effective on the expiration of the period of 31 32 time during which the Governor may veto the bill. If the bill is vetoed by 33 the Governor and the veto is overridden, it shall become effective on the 34 date the last house overrides the veto.
