4	(a) The Arkansas Commission for Coordination of Educational Efforts
5	shall annually elect a chair, a vice chair, and a secretary.
6	(b)(1) The commission shall meet at least quarterly each year.
7	Special meetings may be held at the call of the chair, as needed.
8	(2) The commission shall meet at such times and places that the
9	chair deems necessary, but no meeting shall be held outside the State of
10	<u>Arkansas.</u>
11	(c) A quorum for conducting business is eight (8) members of the
12	commission.
13	(d) The Department of Higher Education shall provide staff support for
14	the commission.
15	(e) The members of the commission may receive expense reimbursement in
16	accordance with § 25-16-902. The expense reimbursement shall be paid by the
17	Department of Education from moneys available for that purpose.

3	(b) The Director of the Department of Education shall call the first
4	meeting of the commission and shall preside at the meeting until the
5	commission elects a chair.
6	(c) At the first meeting, the commission shall elect a chair, a
7	vicechair, and a secretary.
8	(d) The initial terms of the appointed members of the commission shall
9	be determined by lot so that two (2) members have a one-year term, two (2)
10	members have a two-year term, two (2) members have a three-year term, and
11	three (3) members have a four-year term.

13	SECTION 3. EMERGENCY CLAUSE. It is found and determined by the
14	General Assembly of the State of Arkansas that the Arkansas Supreme Court in
15	Lake View School District No. 25 v. Huckabee, 351 Ark. 31 (2002) declared the
16	now existing system of education to be unconstitutional because it is both
17	inequitable and inadequate; that educational reforms applied to public
18	schools has an effect on other segments of the state's educational system;
19	that the cooperation of all segments of the educational system is necessary
20	to ensure the success of educational reforms; that to foster cooperation this
21	act creates the Arkansas Commission for Coordination of Educational Efforts;
22	and that this act is immediately necessary to assist in the enhancement of
23	the state's educational system. Therefore, an emergency is declared to exist
24	and this act being immediately necessary for the preservation of the public
25	peace, health, and safety shall become effective on:
26	(1) The date of its approval by the Governor;
27	(2) If the bill is neither approved nor vetoed by the Governor,
28	the expiration of the period of time during which the Governor may veto the
29	bill; or
30	(3) If the bill is vetoed by the Governor and the veto is
31	overridden, the date the last house overrides the veto.
