8	the transfers from the Education Adequacy Fund, when added to the other

18	SECTION 2. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED
19	SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. For the fiscal year ending
20	June 30, 2005, the Chief Fiscal Officer of the State shall transfer the sum
21	of eighty nine thousand nine hundred forty nine dollars (\$89,949) from the
22	Education Adequacy Fund to the Department of Higher Education Fund Account in
23	order to finance the personal services costs of the Higher Education
24	Recruitment Coordinator.
25	
26	SECTION 3. EMERGENCY CLAUSE. It is found and determined by the 84 $^{ m th}$
27	General Assembly of the State of Arkansas, meeting in Second Extraordinary
28	Session, that this act is necessary due to the November 2002 Arkansas Supreme
29	Court decision declaring the Arkansas public school system financially
30	inadequate. Therefore, an emergency is declared to exist and this act being
31	immediately necessary for the preservation of the public peace, health, and
32	safety shall become effective on:
33	(1) The date of its approval by the Governor;
34	(2) If the bill is neither approved nor vetoed by the Governor,
35	the expiration of the period of time during which the Governor may veto the
36	bill; or

1	(3) If the bill is vetoed by the Governor and the veto is
2	overridden, the date the last house overrides the veto.
