18	ON EDUCATION CONDUCT A STUDY OF THE
19	SALARY INCREASES TO TEACHERS IN SPECIAL

23	WHEREAS, the Joint Interim Committee on Education is requested to
24	conduct a study of the additional personal services for salary increases to
25	teachers in special settings that may not otherwise be eligible to receive
26	the salary increases authorized for other teachers for the biennial period
27	ending June 30, 2005, for the following:
28	(1) Adult education teachers;
29	(2) Co-op math and literacy specialists;
30	(3) Co-op early childhood specialists;
31	(4) Teachers at human development centers;
32	(5) Teachers at juvenile detention facilities;
33	(6) Teachers at the School for Mathematics and Sciences;
34	(7) Teachers at community-based programs serving the
35	developmentally disabled;
36	(8) Teachers at the Department of Correction School District;



1	(9) leachers at intermediate care facilities for the mentally
2	retarded for children;
3	(10) Teachers at Department of Human Services, Division of Youth
4	Services - Residential;
5	(11) Teachers at the Arkansas National Guard Youth Challenge
6	Program; and
7	(12) Teachers that are similarly situated to those listed above,
8	but are not specifically noted,
9	
10	NOW THEREFORE,
11	BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE EIGHTY-FOURTH GENERAL
12	ASSEMBLY OF THE STATE OF ARKANSAS, THE SENATE CONCURRING THEREIN:
13	
14	THAT the Joint Interim Committee on Education conduct a study of the
15	additional personal services for salary increases to teachers in special
16	settings that may not otherwise be eligible to receive the salary increases
17	authorized for other teachers for the biennial period ending June 30, 2005.
18	
19	BE IT FURTHER RESOLVED that to assist in the study, the Department of
20	Education is authorized and directed to gather and compile the information as
21	may be requested by the interim committee to carry out the study.

23	BE IT FURTHER RESOLVED that the interim committee draft appropriate
24	legislation for presentation to the 2005 Regular Session of the Arkansas
25	General Assembly.
