21	SECTION 1. Arkansas Code Title 6, Chapter 11, Subchapter 1 is amended	d
22	to add an additional section to read as follows:	
23	6-11-130. Custodial and maintenance care for school facilities.	
24	(a) The purposes of this section is to:	
25	(1) Ensure that school facilities in Arkansas are properly	
26	<u>maintained;</u>	
27	(2) Eliminate the deterioration of existing and future building	<u>gs</u>
28	to provide a safe and healthy environment for the students, teachers,	
29	administrators, and staff members of the public schools; and	
30	(3) Provide the efficient use of state and local funds in each	
31	of the school districts in Arkansas.	
32	(b)(1) The State Board of Education, in consultation with the Joint	_
33	Committee on Educational Facilities, shall adopt standards for custodial and	<u>d</u>
34	maintenance care of school facilities in the state.	
35	(2) The standard shall provide for best practices in custodial,	2
36	maintenance, and preventive maintenance care.	



1	(c) For the standards for custodial care, the state board shall
2	consider the inclusion of the following:
3	(1)(A) Implementation of a custodial care plan for all
4	facilities owned by a district.
5	(B) This plan shall incorporate a schedule of routine care
6	and renovation cleaning;
7	(2) Implementation of a training plan, including, but not
8	limited to:
9	(A) Chemical right-to-know;
10	(B) Indoor air quality;
11	(C) Blood-borne pathogens;
12	(D) Asbestos Hazard Emergency Response Act of 1986, 20
13	U.S.C. § 4011, two-hour asbestos, low-pressure boiler operator, safety codes
14	and procedures;
15	(E) Crisis management;
16	(F) District employment policies;
17	(G) Routine care procedures;
18	(H) Renovation cleaning procedures;
19	(I) Supply procurement procedures; and
20	(J) Minor maintenance procedures and equipment use and
21	care procedures;
22	(3)(A) Provisions for adequate supplies and equipment to perform
23	the custodial care plan.
24	(B) Adequate space shall be provided for the proper
25	storage of these supplies and equipment.
26	(C) Appropriate training for the use and storage of all
