        SECTION 5. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized
34

     by this act shall be limited to the appropriation for such agency and funds
36
     made available by law for the support of such appropriations; and the
```

1 restrictions of the State Purchasing Law, the General Accounting and 2 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary 3 Procedures and Restrictions Act, or their successors, and other fiscal 4 control laws of this State, where applicable, and regulations promulgated by 5 the Department of Finance and Administration, as authorized by law, shall be 6 strictly complied with in disbursement of said funds. 7 8 SECTION 6. LEGISLATIVE INTENT. It is the intent of the General Assembly 9 that any funds disbursed under the authority of the appropriations contained 10 in this act shall be in compliance with the stated reasons for which this act 11 was adopted, as evidenced by the Agency Requests, Executive Recommendations 12 and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral 13 14 testimony in the official minutes of the Arkansas Legislative Council or 15 Joint Budget Committee which relate to its passage and adoption. 16 17 SECTION 7. EMERGENCY CLAUSE. It is found and determined by the General Assembly, that the Constitution of the State of Arkansas prohibits the 18 appropriation of funds for more than a two (2) year period; that the 19 20 effectiveness of this Act on the date of its passage and approval is 21 essential due to the call of the governor for the convening of an 22 Extraordinary Session, that the provisions of this Act will provide necessary 23 positions and monies for the Office of the Governor to provide essential 24 governmental services for an Extraordinary Session, the delay in the 25 effective date of this Act beyond the date of its passage and approval could 26 work irreparable harm upon the proper administration and provision of 27 essential governmental programs. Therefore, an emergency is hereby declared 28 to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and 29 30 after the date of its passage and approval. If the bill is neither approved nor vetoed by the Governor, it shall become 31 32 effective on the expiration of the period of time during which the Governor 33 may veto the bill. If the bill is vetoed by the Governor and the veto is 34 overridden, it shall become effective on the date the last house overrides

35 36 the veto.
