NOT TO BE INCORPORATED INTO THE ARKANSAS CODE 7 NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. NON-AGENCY 8 CERTIFIED TEACHERS IN SPECIAL SETTINGS BONUS FUNDING PROVISION. During the 9 2004-05 fiscal year each school district that contracts with or otherwise 10 receives teaching services for its students shall pay to the applicable 11 provider of service, a one-time bonus in an amount equal to \$2,500 for each 12 full time equivalent certified teacher employed on October 1, 2004, by the provider that is providing the services to school district students. 13 Immediately upon receiving the monies from the school district the provider 14 15 of service shall make available the \$2,500 one-time bonus to each of its full 16 time equivalent certified teachers that are providing the services to school 17 district students. Each provider will be responsible for notifying the school 18 district of its proportional share of the cost to provide the full time equivalent certified teacher. If a dispute were to occur, the Arkansas 19 20 Department of Education will have final authority to determine the amount due 21 from a school district. 22 23 The provisions of this section shall be in effect only from July 1, 2003 24 through June 30, 2005. 25 26 Section 4. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 27 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. NON-AGENCY 28 CERTIFIED TEACHERS IN SPECIAL SETTINGS BONUS. The Department of Human 29 Services - Youth Services Division, shall provide a one-time bonus of \$2,500 30 for each full time equivalent certified teacher employed by a private provider that is providing teaching services to juveniles in the custody of 31 32 the Youth Services Division. Immediately upon receiving the monies from the 33 Department of Human Services - Youth Services Division the provider of 34 service shall make available the \$2,500 one-time bonus to each of its full 35 time equivalent certified teachers that are providing the services to

juveniles in custody of the Youth Services Division.

5	Section 5. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
6	CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. NON-AGENCY
7	CERTIFIED TEACHERS IN SPECIAL SETTINGS BONUS FOR CHILDREN AGES 3 TO 5 YEARS
8	OLD. The Department of Human Services - Developmental Disabilities Services,
9	shall provide a one-time bonus of \$2,500 for each full time equivalent
10	certified teacher employed on October 1, 2004, by a private provider that is
11	providing teaching services to children ages 3 to 5 years old. Immediately
12	upon receiving the monies from the Department of Human Services -
13	Developmental Disabilities Services Division the provider of service shall
14	make available the \$2,500 one-time bonus to each of its full time equivalent
15	certified teachers that are providing the services to children ages 3 to 5
16	years old.
17	
18	The provisions of this section shall be in effect only from July 1, 2003
19	through June 30, 2005.
20	
21	SECTION 6. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
22	CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. <u>DEFINITION</u>
23	OF CERTIFIED TEACHER.
24	"Certified Teacher " means:
25	(A) An individual who is required to hold a teaching license from
26	the department and who is engaged directly in instruction with students in a
27	classroom setting for more than seventy percent (70%) of the individual's
28	<pre>contracted time;</pre>
29	(B) A guidance counselor; or
30	(C) A librarian;
31	
32	SECTION 7. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
33	CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. RETIREMENT
34	BENEFITS. Bonus payments as required by this act are not considered as
35	salary for the calculation of retirement benefits under the Arkansas Teacher
36	Retirement System or the Arkansas Public Employee Retirement System. However,

1	this special language does not preclude or require any provider of services
2	from including the bonus for retirement purposes.
3	
4	SECTION 8. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
5	CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CHARTER
6	SCHOOL FUNDING RESTRICTIONS. Regardless of any provision of any law to the
7	contrary, the Department of Education shall fund from state monies only those
8	charter schools which provide education services in a traditional public
9	school setting and, if the internet or long-distance learning technology is
10	used, the internet or long-distance learning technology is used as a
11	supplement to the school's traditional classroom setting.
12	
13	SECTION 9. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
14	CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. SCHOOL FOR
15	THE BLIND AND SCHOOL FOR THE DEAF CERTIFIED EDUCATIONAL SUPPORT STAFF BONUS.
16	If sufficient appropriation and funds are available in the budgets of the
17	School for the Blind and the School for the Deaf as approved by the Chief
18	Fiscal Officer of the State during the 2004-05 fiscal year, the schools are
19	authorized to provide a one-time bonus of \$2,500 to each certified
20	educational support staff that may not otherwise be eligible to receive the
21	bonus under Section 2 of this Act. The provisions of this section shall only
22	be in effect from July 1, 2003 through June 30, 2005.
23	
24	SECTION 10. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
25	authorized by this act shall be limited to the appropriation for such agency
26	and funds made available by law for the support of such appropriations; and
27	the restrictions of the State Purchasing Law, the General Accounting and
28	Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
29	Procedures and Restrictions Act, or their successors, and other fiscal
30	control laws of this State, where applicable, and regulations promulgated by
31	the Department of Finance and Administration, as authorized by law, shall be
32	strictly complied with in disbursement of said funds.
33	
34	SECTION $11$ . LEGISLATIVE INTENT. It is the intent of the General Assembly
35	that any funds disbursed under the authority of the appropriations contained
36	in this act shall be in compliance with the stated reasons for which this act

1	was adopted, as evidenced by the Agency Requests, Executive Recommendations
2	and Legislative Recommendations contained in the budget manuals prepared by
3	the Department of Finance and Administration, letters, or summarized oral
4	testimony in the official minutes of the Arkansas Legislative Council or
5	Joint Budget Committee which relate to its passage and adoption.
6	
7	SECTION 12. EMERGENCY CLAUSE. It is found and determined by the General
8	Assembly, that the Constitution of the State of Arkansas prohibits the
9	appropriation of funds for more than a two (2) year period; that due to the
10	November 2002 Arkansas Supreme Court decision regarding the inadequacy of
11	Arkansas public schools the effectiveness of this Act on the date of its
12	passage and approval is essential to the operation of the agency for which
13	the appropriations in this Act are provided, and that in the event of an
14	extension of the Second Extraordinary Session, the delay in the effective
15	date of this Act beyond the date of its passage and approval could work
16	irreparable harm upon the proper administration and provision of essential
17	governmental programs. Therefore, an emergency is hereby declared to exist
18	and this Act being necessary for the immediate preservation of the public
19	peace, health and safety shall be in full force and effect from and after the
20	date of its passage and approval.
21	If the bill is neither approved nor vetoed by the Governor, it shall become
22	effective on the expiration of the period of time during which the Governor
23	may veto the bill. If the bill is vetoed by the Governor and the veto is
24	overridden, it shall become effective on the date the last house overrides
25	the veto.
